In the Annexure to each licence:

In the column opposite "Trading Hours":

1. Omit "6am to 11pm" and substitute:

"(a) for all Permitted Activities except for the Permitted Activities specified in (b) – 4.00am to 11.00pm

(b) for the sale and supply for consumption off-premises to inbound international passengers – 5.00am to 11.00pm."

2. Below the column "Advertising and Signage", after "4BX" insert:

"Reporting

If the licensee receives an application for a sub-licence, or a variation to a sub-licence, which, if granted, would result in the sub- licensee engaging in a Permitted Activity between 4.00am and 6.00am, the licensee must, before granting or refusing the sub- licence, provide a copy of the application to the Department.

If the licensee grants a sub-licence or a variation of a sub-licence for any part of the licensed premises, the licensee must provide a copy of the sub-licence or the variation to the Department within 7 business days of granting it.

By 1 April 2016, the licensee must provide to the Department a copy of each sub-licence in respect of any part of the licensed premises which is in force on the date when *Variation of Passenger Terminal Licences – Sydney (Kingsford-Smith) Airport* commences.
