Diane Cornell	Diane Cornell is Special Counsel in the Chairman's office at the Federal Communications Commission (FCC), the USA's primary authority for communications law and regulation. Ms Cornell has responsibility for issues in the FCC's International Bureau, as well as for FCC process reform. Ms Cornell has previously served as Vice President for Government Affairs at Inmarsat and Vice President, Regulatory Policy at CTIA, The Wireless Association.
Richard Hooper CBE	Richard Hooper CBE is former Deputy Chairman of OFCOM, the United Kingdom's independent regulator and competition authority for the UK communications industries. Mr Hooper CBE is currently chair of the Broadband Stakeholder Group, the UK government's advisory body on broadband. He is also Chairman of The Copyright Hub and is Senior Independent Director on the board of VocaLink Holdings Ltd which runs the (regulated) UK national payments infrastructure. He has in the past advised the MDA and the IDA in Singapore, and Chorus Ltd and Telecom New Zealand in New Zealand.
