### 1 Name of Exemption Instrument

This Instrument is the *Telecommunications (Network Exemption—TransACT Very Small Scale Networks) Instrument 2012 (Amendment No.1 of 2020)*.

### 2 Commencement

This Instrument commences on the day it is signed.

### 3 Amendment

The *Telecommunications (Network Exemption—TransACT Very Small Scale Networks) Instrument 2012* is amended as set out in the Schedule to this Instrument.

### Schedule—Amendments

#### *Telecommunications (Network Exemption—TransACT Very Small Scale Networks) Instrument 2012 (Amendment No.1 of 2020)*

##### 1 Cause 2 (Cessation)

Omit the clause in its entirety, substitute:

This Instrument ceases on the earlier of:

- a. the day after:
  - i. a functional separation undertaking; or
  - ii. a deemed standard functional separation undertaking relating to local access lines forming part of a Victorian Very Small Scale Network or an ACT Very Small Scale Network first comes into force for the purposes of Part 8 of the Act; and
- b. the day that is the second anniversary of the day on which the *Telecommunications Legislation Amendment (Competition and Consumer) Act 2020 (Cth)* receives the Royal Assent; and
- c. 30 June 2023.

##### 2 Cause 3 (Definitions)

Insert:

***deemed standard functional separation undertaking*** means a functional separation undertaking covered by a determination under subsection 151B(1) of the Act, as amended by Schedule 2 to the *Telecommunications Legislation Amendment (Competition and Consumer) Act 2020 (Cth)*.

***functional separation undertaking*** has the same meaning as in section 142A of the Act, as amended by Schedule 2 to the *Telecommunications Legislation Amendment (Competition and Consumer) Act 2020 (Cth)*.
