

Update on Norfolk Island Regional Council matters

It will be great to have Norfolk Island Regional Council interim Administrator Mike Colreavy back on island next week, ahead of the next Council meeting. He will also be meeting with community groups and individuals again.

As you may have seen, the independent Commissioner appointed to conduct the public inquiry into NIRC, Carolyn McNally, will also be on Norfolk Island this month.

Ms McNally will visit from 13–15 April 2021.

While on-Island, she will be conducting community sessions to help inform the inquiry within its Terms of Reference.

The Inquiry's Terms of Reference focus on whether the NIRC has performed its financial and asset management roles in accordance with relevant provisions of the Local Government Act 1993 (NSW) (NI).

Kingston update

It was fantastic to welcome the Advisory Committee for the Kingston and Arthur's Vale Historic Area (Kingston) back to island last week. Due to COVID-19 impacts in 2020, it was the first face-to-face meeting for new members Susan Prior and Dr Jane Harrington. Sadly, it was also the final meeting for Ms Kristal Buckley. Kristal's vast knowledge and experience of cultural heritage management around the world has proven extremely valuable in guiding the management and future direction of Kingston. Unfortunately, Dids Evans was unable to join us and we wish him a full and speedy recovery.

The Committee took the opportunity to see and hear first-hand the achievements and challenges of Kingston, with Jimmy Quintal showing the members the incredible restoration work being undertaken by the site maintenance team, and demonstrating the process of shingle-making.

Rose Evans discussed Norfolk's enviable tourism recovery, and the opportunities and challenges that presents for Kingston, the museums and the island as a whole. Following consultation with several on-island groups, an excited Maree Evans shared the vision for new interpretation at the site to better unlock its diverse and intriguing history.

Archaeologist Tom Sapienza impressed the group with new maps and knowledge obtained using historical images and sketches, GIS data and lidar imagery and the potential this provides for underpinning site interpretation and the planning of capital works projects.

The Committee visited several key buildings to discuss future opportunities and challenges for use and activation to inform future site master plan discussions. Members were able to meet with Helen Pedel, Chair of the Community Advisory Group (CAG), and informally with other members of CAG to hear about their experiences, goals and challenges for the site.

Economic stimulus package update – tourism projects

As part of the tailored COVID-19 package announced in July 2019, the Australian Government committed \$475,000 to promote tourism on Norfolk Island ensuring that, as borders continue to slowly reopen, we are well placed as a world-class destination for domestic travellers looking to tour their own backyard.

Since then, significant progress has been made on the three projects funded through the tourism aspect of the stimulus package.

These include the White Tern project to deliver a digital platform and marketing campaign for the Norfolk Island Regional Council (NIRC) to target and drive digital campaigns. The campaigns have commenced and initial data indicates they are generating considerable interest and travel to the island.

Another initiative is the production of a documentary hosted by Ray Martin and filmed by award-winning landscape photographer Ken Duncan. This project is in partnership with Tourism Australia. Ray, Ken and the production crew are on-Island this week to begin filming.

Another exciting promotional tool is the production of four 30-minute episodes on Norfolk Island, featuring six stories per episode, for broadcast on Channel 9, 9Life and 9Now. The broadcast will be complemented by an advertising campaign that includes commercial airtime, billboards and TV commercials. The production team have been delayed on two occasions due to COVID-19 events on the mainland, and at this stage are expected in May.

Thanks to Unique Tourism Collection (UTC) for its support of the production team both off and on island to ensure the Ray Martin documentary and the Channel 9 travel series are available for marketing later this year.





Water quality update

Following Senversa's recent visit on island to progress the detailed environmental investigation into PFAS, I am pleased to update you that the water freighted to the island in 2019 as part of the initial PFAS response is no longer required. It will now be made available to local not-for-profit community and sporting groups for their use. The water is available in 10 litre containers, 1.5 litre and 600ml bottles. The 10-litre containers are able to be re-used and all are encouraged to get creative with re-purposing containers and bottles in your groups, homes and maybe even your 'Wearable Art' entries.
