

# Norfolk economic

#### recovery

Hard work continues on a range of initiatives and projects that are focused on restarting and building the Norfolk Island economy through COVID-19 recovery. At a Federal level, income support has been provided in JobKeeper, JobSeeker, JobMaker and JobTrainer. Employers on island are actively seeking staff for a number of roles in our hospitality and tourism sectors.

Please be mindful that some of these supports are scheduled to cease in March 2021, so now is the time to tap into these programs, if needed.

The Department of Infrastructure, Transport, **Regional Development and** Communications has worked with my office and the Assistant Minister's office to schedule additional Air New Zealand flights and to progress work in relation to the possibility of Norfolk Island becoming a domestic route. Similarly, work continues to progress in relation to the freight issues and pressures presented due to limited sea freight options. We are working closely with the Norfolk Island Regional Council General Manager to identify and implement short term solutions.

#### Economic stimulus package update

Works are progressing well across the 22 Norfolk Island COVID-19 economic stimulus package projects, funded by the Australian Government, with a number of projects now near completion. These include the Cockpit Reserve bridge repairs, and improvements to the reserve area. It also includes the beginning of the upgrades to the Norfolk Island Squash Club, with court side grandstands completed. The Department of Infrastructure, Transport, Regional Development and Communications is collaboratively working with Norfolk Island Regional Council to deliver these important projects for the benefit of residents and visitors.

## **KAVHA** update

While the COVID-19 pandemic has affected visitor numbers to the island and the Kingston World Heritage site in 2020, it has also given staff time to progress a number of key projects to enhance the site, including the ongoing restoration of several buildings. This will bring great benefits as visitors continue to return to Norfolk.

A key achievement has been the **adoption of Norf'k language on new signage and the visitor guide**, recognising the cultural traditions of the island and its identity. The new Kingston logo draws together the four strands of the island's heritage - Polynesian, British Colonial, British Penal and Pitcairn - and weaves them together with the Norfolk heritage into a single unified approach and presentation.

The **\$770,000** Australian Government commitment through the COVID-19 Relief and Recovery package is supporting the continued implementation of the Kingston branding across the site, as well as local employment opportunities. A new temporary Interpretation Coordinator/Researcher is currently being recruited to join the team on island to deliver the projects. Work will include replacement of more signage to incorporate increased use and recognition of the Norf'k language, as well as different ways and locations to better share the currently untold stories of the site across all settlement periods.

These projects will link in with a **new mobile app in development**, planned for launch in January 2021. The app will take advantage of the new 4G network (via the Building Better Regions Fund). A new tour of Kingston will be made available for free download containing more than 40 stories. The new app will also enable us to host additional new trails with Norfolk Island Museum and the community next year.

The site is fortunate to have secured funding for an **archaeologist who will be employed on island under an 18-month contract**. Archaeologist Tom Sapienza, who many on island will know from his PhD research on the Melanesian Mission, will travel to the island with his family in early 2021 to begin work at Kingston. Tom was recruited from a competitive field, and we are really excited by his appointment. Tom will work alongside the Heritage Manager and wider team to deliver a number of safety and improvement projects at Kingston and contribute

his expertise to archaeological site investigation.

There is also considerable work being done to address water quality issues in Emily Bay, this includes a short-term solution with input from NIRC, the department, Marine Parks and Heritage staff as well as feasibility investigations into longer term options. Local contractors are assisting the department with **inspection of 22 identified septic and effluent systems in Kingston**.

### **Current consultations**

Recently, Advisian and Consult Marine presented the detailed design (80%) for the **Kingston Pier Channel** Construction project to the Norfolk Island community through a series of phone and online interviews seeking feedback on the updated design. The presentation included an overview of investigations undertaken to develop the initial design options and key issues from earlier consultation activities. It also covered reasons for selection of the option known as Option 3A to the 80% stage and a strategy for addressing the structural issues with the pier. The project team thanks all who attended the consultation sessions, providing further valuable feedback as the design looks to progress to the final design (100%) stage.

A number of community consultations have been scheduled for the first half of next year, including around emergency management, the Norfolk Island strategic plan and ports management. More information will be provided to the community about these consultations – including dates, engagement opportunities and locations – in early 2021.
