As discussed earlier this week, set out below is a draft approach to Phase 4 delivery of LRCI. I understand that once you are comfortable, the next step will be to consult with Minister McBain's office on the proposed delivery arrangements.

Proposed Phase 4 Delivery for LRCI

Phase 4 funding allocation:

- Comprises \$500M announced previously, and \$250 election commitment – this will together be known as LRCI Phase 4
- The previously announced \$500m funding allocation was calculated using the same formula as Phase 1 and Phase 3*. For the \$750M we propose keeping this formula, which is based on road length and population.
- Phase 2 methodology prioritised population, which would not achieve the policy intent for Phase 4.
- Based on Electorate Demographics the proposed methodology delivers the outcome of sending more money to Provincial and Rural councils. Indicative figures are as follows:
 - o s47C Councils are Inner/Outer Metropolitan and would receive a total of s47C
 - o s47C Councils are Provincial/Rural and would receive a total of s47C

NB, this adds to 750,000,102, with rounding error of \$102. Figures are indicative and we'll finalise in the brief.


\$250m Election Commitment – Roads Focus

- Require s47C Council's funding allocation in Phase 4 be allocated to road infrastructure projects, using the same eligibility requirements as Phase 3 Guidelines.
- Road projects to include any project delivering road related infrastructure including new base, grading, sheeting, sealing or tar/ bitumen, traffic calming, pedestrian safety, (active)transport, drainage/ stormwater projects, bridges.
- s47C

Background

- Currently 40% of \$2.5 billion is allocated to road infrastructure projects
- Approximately 40% of Councils have nominated at least one road project
- Including a requirement for Phase 4 that s47C Councils Phase 4 nominal funding allocation be for a road infrastructure project will pull the other s47C into commissioning road work.

Next Steps

Once a Phase 4 model is settled, we will arrange to provide a brief with program guidelines and grant agreements to the Minister for her approval.
