MEETING: South East Queensland (SEQ) City Deal – Leadership Group meeting

Timing: 9:30am – 10:30am AEST, Friday 26 August 2022

Venue: Virtual meeting via Zoom.

Meeting with: The Queensland Deputy Premier, Hon Dr Steven Miles MP, and Cr Adrian Schrinner. Chair of Council of Mayors (SEQ) and Lord Mayor of Brisbane (biographical information detailed at **Attachment A**).

This meeting seeks to consider the strategic direction of the City Deal moving forward and establish agreement on the level of detail in the draft Implementation Plan.

Prior meetings: This is the first Leadership Group meeting since Deal partners signed the SEQ City Deal on 21 March 2022.

Our Proposed Objectives: Leaders are asked to consider the outline of the draft Implementation Plan as well as potential new members to join the Deal's Industry Reference Group.

Their Objective: Deal Partners are seeking trilateral agreement to progress the draft Implementation Plan through respective approval processes.

Key Points – SEQ City Deal:

- 1. The \$1.8 billion SEQ City Deal was signed on 21 March 2022 between the Australian Government, the Queensland Government and the Council of Mayors (SEQ). Since signing, officials have been working to agree arrangements for the delivery of Deal commitments and to develop the Implementation Plan, which is due for publication by the end of 2022.
- 2. The Deal includes 31 commitments (see **Attachment D**) that will deliver critical investment to create jobs for the local community and provide an economic boost for the region.
- 3. The Australian Government will invest \$567.77 million in the SEQ partnership, \$47B
