PERTH CONCERT HALL REDEVELOPMENT PROJECT

I am pleased to inform you of my Government's decision to increase its funding commitment to the redevelopment of the Perth Concert Hall project by a further \$97.6 million. This brings the WA Government's total commitment to \$136 million, and the total project funding to a significant \$150 million.
