Reading from the left side of the flowchart:

- 1. The main pathway begins at 'Application (7 & 12)'
 - Applicant prepares an application in consultation with the relevant AOC.
 - An application must set out the:
 - the proposed controlled activity
 - the proposed location of the activity
 - the proposed duration of the activity
 - the purpose of the activity
 - the proposed maximum height (AHD and AGL) of the proposed building, structure or thing; and any temporary structure or equipment intended to be used in the erection of the proposed building, structure or thing.
- 2. 'Application Received'
 - A decision is to be made within 40 working days beginning on the first working day after the day the application is received (18(1)).
 - The Secretary may extend the period for making a decision in relation to an application by a further period of not more than 10 working days (18(2)).
 - a. The flowchart branches off the main path to provide alternative courses of action. One of the following 3 options may be pursued, if relevant:
 - i. The AOC may refer the application to CASA, Airservices and Defence for advice (14(2))
 - ii. The application may be referred to the secondary surfaces application process
 - iii. The application may be referred to the sensitive controlled activities application process.
- 3. If none of the 3 options are pursued at point 2a above, the flowchart continues along the main path, whereby an application progresses to the 'AOC Delegate's Approval (17 & 26(2)(a)(ii))'.

Stage 1 – Permission to apply to carry out sensitive controlled activities

Subtext: A person must not apply under section 12 for approval to carry out a sensitive controlled activity (section 6) unless the person has first been given permission under section 13.

Reading from the left side of the flowchart:

- 1. The main pathway begins at 'Request for permission to apply (13(1) to (4))'
 - The request must set out:
 - the proposed sensitive controlled activity
 - the proposed location of the activity
 - the proposed duration of the activity
 - the proposed maximum height (AHD) of the proposed building, structure or thing; and any temporary structure or equipment intended to be used in the erection of the proposed building, structure or thing
 - one of the circumstances specified under paragraph 13(4)(e) that the applicant believes justify the making of an application under section 12 for approval to carry out the activity.
- 2. 'Assessment (13)'
 - The Secretary may give permission, if the Secretary is satisfied that the proposed activity would be a temporary controlled activity, and:
 - the activity is required to carry out emergency recovery works, emergency restoration works or public infrastructure works; or
 - it is reasonably likely that the activity could be carried out without any significant interference to airport operations; or
 - exceptional circumstances exist that justify permitting an application.

- 4. 'Notice of Decision (13(5) to (9))'
