- 1. The ToRs refers to the "aviation sector" that, in our opinion does not focus on what is the "aviation transport sector".
 - a. Irrespective whether it is private, recreational or commercial, it is an air transport that we are talking about.
 - b. Air Transport sector covers all aspects of aviation, including manufacture and associated support sectors.
- 2. Review the changing nature of aerodromes with new technology aircraft and other air transport vehicles currently approaching design approvals.
 - a. Vertiports, urban mobility vehicles, short take-off & landing vehicles.
- 3. One of the priorities has to be obtaining global recognition of Australian designed and manufactured aircraft and parts globally.

 - b. This will require lifting Australia's skills to global standards to support the manufactured products.

We don't think these are covered by the ToRs and need to included to get the focus back on being a trading partner in the global civil aviation system.

Australia needs to globally accepted in the global aviation system without restrictive difference that affect recognition and trade.
