Have your say on the exposure draft Jervis Bay Territory Rural Fires Rules 2024

The Department of Infrastructure, Transport, Regional Development, Communications and the Arts (the department) is remaking the *Jervis Bay Territory Rural Fires Rule 2014* (the 2014 Rules) before it sunsets on 1 October 2024.

Following initial consultation earlier in the year, we have prepared the draft *Jervis Bay Territory Rural Fires Rules 2024* (the draft Rules) to replace the 2014 Rules. We want to hear from interested parties about how well these will support an effective fire management framework in Jervis Bay Territory (JBT). Your feedback is important to ensuring they operate well.

Why we are remaking the 2014 Rules?

The 2014 Rules commenced on 1 May 2014 and, under the *Legislation Act 2003*, sunset on 1 October 2024. Sunsetting is an automatic repeal of instruments after a fixed period. This sunset mechanism triggers a review of the Rules and an opportunity to remake the Rules so they remain fit-for-purpose.

The 2014 Rules support the *Jervis Bay Territory Rural Fire Ordinance 2014* (the Ordinance). The Ordinance and Rules together provide the legislative framework for fire management services to the JBT. If allowed to sunset, the Rules will no longer operate, which would create a gap in fire risk management in JBT.

What will the draft Rules do?

The draft Rules will replace the 2014 Rules, which are due to sunset on 1 October 2024.

Both sets of rules are modelled off the *Rural Fires Regulations 2022* (NSW), with modifications to reflect the JBT's jurisdictional and administrative circumstances as appropriate. Many of the provisions in the draft Rules are identical to the existing New South Wales (NSW) regulations, to ensure NSW emergency services personnel have clarity as to their role and their rights and responsibilities regardless of whether they are operating in the JBT or in NSW on any given day.

At a high level, the draft Rules cover the following matters:

- Set out eligibility for becoming and remaining a rural fire services brigade member and the process, including review rights, for removing a person from a brigade register.
- Set out the process to be followed where a brigade member is considered to have committed a disciplinary breach, including appeal rights.
- Specify administrative matters relating to the Fire Management Committee, incident reporting in relation to fires and other emergencies, and record keeping for brigade members receiving awards for bravery, other meritorious service and long service
- Set out what is prescribed land and which entity is a prescribed authority for the purposes of the Ordinance.
- Prescribe matters relating to fire permits for land in the JBT, including notice requirements.
- Set out the requirements for notices relating to hazard reduction work in the JBT.
- Specify the display and notice requirements for the draft JBT bushfire management plan, including that it be displayed for 42 days and interested persons may make submissions in that period.
- Set out the requirements for service of notices or directions as required or permitted under the Ordinance.
- Specify when volunteer rural fire brigade members can assist public authorities such as NSW Fire
 and Rescue, the AFP, the NSW Ambulance and the NSW SES in relation to fires, incidents and other
 emergencies.

The Rules do not:

- create offences or civil penalties
- provide powers of arrest or detention, or entry, search or seizure
- impose a tax, or
- directly amend the text of the Ordinance.
