

Please see below for comment on your statements:

"The petition initiated by Mr Rudd will be considered by the Petitions Committee of the Parliament. In line with its usual practice the Committee is expected to refer it to the relevant portfolio Minister - in this case the Minister for Communications - for advice.

The petition has already been considered by the Committee prior to it being published and made available to collect signatures. The Committee considers petitions against the standing orders to make sure they are compliant. When the petition has closed for signatures (today is the last day) it will be presented to the House and referred to a minister for a response. Because this petition is requesting a Royal Commission, it will be referred to the Attorney-General. This has been decided upon advice from the AGs department. They may request input from your office in the preparation of the response, but will have main carriage of it.

"The Minister will consider the petition and prepare a response to the Committee should it be referred to him.

Correct, see comment above, but it will be the AG and not your Minister.

"The lodgement of a petition with the Parliament does not compel the Parliament to consider the matter or to take the action proposed in the petition.

Correct. A petition is one indication of the support within the community on a certain issue and not a binding vote. It is up to the Government of the day as to what action, if any, is taken.

<sup>s47F</sup> has said you are seeking some further information on the petitions process.

Petitions presented to the House are usually referred by the Petitions Committee to the Minister who is responsible for the subject area of the petition. The Minister will send a response to the Petitions Committee which will also be presented to the House. Unlike other Parliaments around the world, where petitions which reach a 'signature threshold' are debated, **petitions are not debated in the House of Representatives.** 

In the case of the <u>Rudd petition</u>, once the petition closes tomorrow, it will be likely referred to you by the Petitions Committee. You will be asked for a response, although strictly speaking you do not have to provide one. For the avoidance of doubt, there is no way that the petition can directly result in a Royal Commission being called – only the Governor-General can do that, on the advice of the Prime Minister.

Thank you for your email dated 9 November 2020, concerning petition number EN1938, requesting the establishment of a Royal Commission to ensure the strength and diversity of Australian news media.

The signatories of the petition have expressed concern about the state of the Australian news media industry, with a particular focus on diversity of media ownership. The signatories are requesting that the House of Representatives support the establishment of a Royal Commission to ensure the strength and diversity of Australian news media.

As a matter of process, while the petition is presented to the Parliament, it is not the Parliament which has the power to initiate a Royal Commission. Royal Commissions are initiated by the Governor-General on the advice of the Government of the day. The Australian Government will not be advising the Governor-General to initiate a Royal Commission into Australian news media.

The Government supports a diverse and sustainable media sector. It also recognises that quality news and public interest journalism play an important role in the functioning of Australian society and democracy and is essential to informing local communities, particularly in relation to national and global events.

The *Broadcasting Services Act 1992* contains a number of rules regarding the control and diversity of media ownership in Australia. These rules support a diverse media sector by limiting the number of media operations that can be controlled by a person in a licence area. The Act defines a media operation as a commercial television broadcasting licence, a commercial radio broadcasting licence, or an associated newspaper.

The Government recognises that media companies have been facing challenging market conditions with declining audience numbers and difficult advertising conditions. The sharp downturn in advertising revenue across the whole sector due to the COVID-19 pandemic has significantly increased these challenges.

The Government has acted decisively in the national interest to support businesses and address the significant economic consequences of COVID-19, and has announced a range of measures to help Australian media businesses, including:

- **Investing in regional journalism** A \$50 million Public Interest News Gathering program for commercial television and radio broadcasters and newspapers in regional Australia. This has provided funding to 107 regional publishers and broadcasters who applied to the program. In addition, the Government will provide \$5 million to the Australian Associated Press Limited Newswire under the program. This increases the Government's investment in the program to \$55 million.
- **Regional and Small Publishers Innovation Fund** The Government brought forward the release of \$5 million from the Regional and Small Publishers Innovation Fund. The Fund's 2020 round has provided funding to 41 regional and small publishers producing public interest journalism.
- **Tax relief** A 12-month waiver, backdated to start from 14 February 2020, of spectrum tax for commercial television and radio broadcasters worth \$41 million.
- Short-term red tape relief Emergency suspension of content quotas in 2020.
- Support for Australian screen content The Government has simplified regulations and is injecting \$53 million into the development and production of local film and television.

On 27 November 2020, the Government announced the next stage of its media reform program with the release of a media reform green paper. The green paper outlines a set of proposals to improve the sustainability of Australian media businesses and the range and quality of services and content available to all Australians. The proposals in the green paper are not final, and the Government welcomes an open dialogue with stakeholders in regional Australia during the consultation period.

In addition, on 9 December 2020, the Government introduced the News Media and Digital Platforms Mandatory Code into the Parliament. The code will support a diverse and sustainable news media sector by addressing the bargaining power imbalance between news businesses and digital platforms, and requiring Google and Facebook to fairly remunerate news businesses for the use of their content online.

The development of a code of conduct is part of the Government's response to the Australian Competition and Consumer Commission's Digital Platforms Inquiry to promote competition, enhance consumer protection and support a sustainable Australian media landscape in the digital age.

In addition to what you have set out below in relation to the Green Paper and the QTB on Regional – please pass on to our Senators that:

- Current media ownership restrictions in the Broadcasting Services Act prevent a TV broadcaster from
  owning more than one licence in any market (except in some very small markets where there are exceptions
  allowing the existing two licence holders to hold the third licence in a JV);
- What the Regional broadcasters have put forward in their submission to this inquiry (and have been campaigning for under the banner Save Our Voices) is that those ownership restrictions should be removed for regional broadcasters and they should be permitted to merge with each other – so there might just be one licensee in a market.
- The Green Paper process offers an opportunity for broadcasters regional and metropolitan to put forward proposals and ideas which, in their view, would make their businesses more sustainable.

raised an issue (again) today re the green paper and I've found these words which should provide some background:

On 27 November 2020, the Government announced the next stage of its media reform program with the release of a Media Reform Green Paper.

The Green Paper outlines a set of proposals to improve the sustainability of Australian media businesses and the range and quality of services and content available to all Australians.

The Green Paper proposes to:

- offer commercial broadcasters a one time, irrevocable choice to operate under a new commercial television broadcasting licence, with a reduced regulatory burden, provided they agree to move at a future point to using substantially less radiofrequency spectrum;
- promote the public interest derived from spectrum by encouraging multiplex sharing by broadcasters;
- introduce an investment obligation for subscription and advertising video-on-demand services, with details to be further developed over the next 12 months;
- invest in the future, by using the proceeds raised through the reform process to fund public policy initiatives that deliver value for the Australian public and support the media sector; and
- formalise the role of national broadcasters as key providers of Australian content.

The centrepiece of our proposed reforms is a new category of licence for commercial television broadcasters. Under this proposal, the holders of existing commercial television broadcasting licenses would have the option to make a one-time transition to a new licence.

The new licence would allow broadcasters to operate under a lower cost model with two important changes to the present arrangements.

- First, the holder of a new licence would no longer be required to pay a tax for the use of spectrum.
- Second, the holder of a new licence would be required to transition to using less radiofrequency spectrum, to be initiated by Government when certain conditions were met.

Advances in technology mean that broadcasters could move to transmission arrangements which use less spectrum, but which maintain their service levels at close to current levels with a minimal impact on viewers.

This provides an opportunity to realise a second digital dividend through the auction of available spectrum.

A portion of auction proceeds could be used to fund measures that support key media policy outcomes such as the production and distribution of public interest journalism and the creation and distribution of Australian content.

The release of the Green Paper is intended to start a conversation with industry and the Australian public about what our future media regulatory framework should look like.

The proposals in the Green Paper are not final, and the Government welcomes an open dialogue with industry during the consultation period.

Importantly – this is also an opportunity for television broadcasters – regional and metropolitan – to put forward other proposals and ideas which, in their view, would make their businesses more sustainable.

The Government is seeking public submissions on the Green Paper by 23 May 2021. The Government appreciates the significance of the proposed reforms and will take all stakeholder feedback into account in the development of the final reform proposals.
