

On Sunday 28th March child rapist Anthony Sampieri died in custody from liver cancer, just two years into a life sentence.

Sampieri, aged 56, attacked a seven-year-old girl in the toilets of a dance studio at Kogarah in Sydney's south in November 2018.

The girl had rushed to the toilets while her mum, intending to wait for the victim's sister who was at dance class, parked the car outside.

But Sampieri was waiting, armed with cords and a knife. He punched the child in the face, bound her wrists and ankles and attached them to her neck, and told her he would cut her throat if she made a sound.

He sexually brutalized the victim in the female toilets, before moving her to the male block.

During the 50-minute ordeal he forced the young girl to perform acts of depravity, raped her repeatedly, stuffed toilet paper in her mouth, and used his mobile phone to film the abuse.

He only stopped his violence when searchers approached the cubicle where he had the girl imprisoned. He fled, leaving her bound and gagged.

Sampieri claimed that ice addiction was to blame, but pornography was more likely to be the primary cause of his vicious, predatory behaviour.

He had used pornography from his early teens. Pornography, including men having power over schoolgirls and teens was found at his home. Just prior to the attack on the defenseless seven-year-old, Sampieri watched porn in the male toilets and engaged in a sex act, then repeated the same actions in the female toilets.

FamilyVoice's Child Internet Safety Coordinator Peter Stevens is deeply concerned. He met Kristine Kaukomaa, senior advisor to Communications Minister Paul Fletcher, recently to continue our eight-year push for a "clean" Australian internet.

Peter told Kristine that a 5-year-old with a smart phone could access porn with two "clicks". The top search result gives 40 free video options, each containing explicit hard core "gonzo" porn - close-up video of genitals and sexual intercourse. Almost all of the top twelve videos are graphic perversions depicting sex between family members - "Step Mom," "Step Sister," "Mom," "Step Daughter," "Virgin," "Rough Sex," "MILF," "Gangbang," "Granny," "Teen," "Mature," and "Babysitter."

It's twelve months since the release of the Age of Innocence Report recommending age verification for Australian porn sites to protect children from harm. The federal government has the power to implement the change but has been slow to respond.

FamilyVoice and other groups are waiting for an official response – and action. The government's response is completed but tabling in parliament is delayed due to a Covid pile-up of business.

Boys addicted to pornography grow up with little respect for women and can become violent partners and husbands, or even predatory criminals like Sampieri. Right now, in Australia, future generations of rapists are being molded by free porn pushed to kids.

Government's responsibility is to protect. Age verification is a good step towards a cleaner internet. It needs to happen now.
