

#### 2. Lansdown Eco-Industrial Precinct

<u>Current Status</u> – Unlocking access to Lansdown Eco-Industrial Precinct and creating Townsville as the Powerhouse of the North are key commitments in the Townsville City Deal. Lansdown Eco-Industrial Precinct was confirmed by the Townsville Industrial Development Board as a critical component of the Southern Industrial Corridor. Lansdown has attracted substantial private sector interest with over half of the developable land committed or conditionally committed to advanced battery manufacturing, clean energy, and battery minerals processing industries. Investment in enabling infrastructure will remove red tape in development feasibility and financial investment decision process, accelerating projects and unlocking thousands of jobs years ahead of schedule. If funding was secured, completion of all enabling infrastructure would be complete by the end of the 21/22 financial year.

<u>Background</u> - The Lansdown Eco-Industrial Precinct will be Northern Australia's first environmentally sustainable, advanced manufacturing, processing and technology estate powered by locally generated renewable energy creating long-term sustainable industry contributing to the NQ economy. The precinct addresses Australia's pervasive manufacturing challenge by co-locating industry with low-cost power supplied from the adjacent 400MW solar farm by Edify Energy thus reducing ongoing operating costs, and regionalising manufacturing job creation, outputs and outcomes.

Investment Required - A \$50 million investment would deliver:

 Intersection upgrades to provide road access to the precinct, which would also have safety outcomes for Woodstock residents;



- Relocation of the rail infrastructure to maximise strategic opportunities for creation of a multiuser rail siding within the precinct providing a second method of transporting product to and from the site through to the Port of Townsville and the North West Minerals Provinces;
- Provision of a raw water supply for proponents from the Haughton Pipeline Duplication Project located just 13km from the Precinct;
- Creation of internal access roads that will immediately facilitate finalisation of the first stage of DriveIT NQ and enable operations for all early Precinct users to commence; and
- A precinct-wide gas microgrid that will support 24-hour industrial operations within the precinct, supplementing low-cost solar power feed for day-time uses.



## **Purpose** of Lansdown

The Lansdown Eco-Industrial Precinct will become Northern Australia's first environmentally sustainable, advanced manufacturing, processing and technology estate powered by locally-generated renewable energy.

The Precinct is located approximately 40 km South of Townsville and is zoned for High Impact Industrial Use. The location offers significant strategic advantages including its positioning to essential infrastructure and logistic networks needed to ensure the long-term sustainability of the North Queensland economy.

Advantages of the Precinct include:

- direct access available to the Great Northern Railway (connecting the Port of Townsville to Mount Isa);
- close proximity to the Port of Townsville via high volume road corridors (Flinders Highway, Bruce Highway and Southern Port Access Road) including B-Triple carriageway capacity on major routes to the Port;
- immediate adjacency to the Enertrade Gas Pipeline;
- Woodstock Ergon Sub-Station;
- Co-location with low-cost, locally-generated energy from the approved 200-megawatt Majors Creek Solar Farm by Edify Energy (located at 67 Maconachies Road, Majors Creek);
- Future connection of the Precinct to the Haughton Pipeline which will provide raw water supply for industrial users.

The Precinct is 2200 hectares and has already attracted substantial private sector interest with over half of the land committed or conditionally committed to advanced battery manufacturing, clean energy, and battery minerals processing industries.

In addition to DrivelT NQ which are under construction, three companies, Queensland Pacific Metals, Edify Energy and Imperium3 Townsville, have signed up to establish themselves at the Precinct.

## QUEENSLAND PACIFIC METALS (QPM)

Queensland Pacific Metals (QPM) have been conditionally-committed 289 hectares for development of a nickel refinery. The development utilises sustainable technology which results in zero liquids discharge and potentially zero solids discharge.

The refinery will utilise the Direct Nickel Process (DNi), which employs a nitric acid leach under atmospheric conditions, to produce intermediate products. These will then be further refined to produce battery chemicals.

The DNi Process has many advantages including:

- The ability to recover all valuable metals from the ore including nickel, cobalt, aluminium, iron and magnesium
- Shorter time frame and cheaper cost of construction as stainless steel can be used, which is not corroded by nitric acid
- >99% nitric acid recycled
- Lower environmental footprint the remaining residue is a benign silicate which can be dry stacked, eliminating the need for a tailings dam.

#### Current Status:

- > QPM have well advanced project planning. Offtake Memorandum of Understandings have been signed with major customers Samsung SDI and LG Chem.
- Planning and design works are underway with construction expected to commence in 2022. Production from the refinery is anticipated in 2023.

#### IMPERIUM3 LITHIUM-ION BATTERY MANUFACTURING FACILITY

186 hectares have been conditionallycommitted to Imperium3 consortium (iM3TSV) to develop an 18 GWh lithium-ion battery manufacturing facility.

iM3TSV has selected a cylindrical 32700 form factor for its battery cells as it is better suited to high volume manufacture and offers improvements in performance and cost whilst still maintaining flexibility in the range of applications for its use.

The manufacturing process was developed with the iM3TSV's strategic partners and vendors of manufacturing equipment including Durr Megtec and Siemens looking to incorporate the latest advancements in battery cell production to increase overall efficiencies and production yields. The solution was delivered by Brisbane-based engineering specialists Ausenco, which was responsible for combining the individual vendor packages into a fully integrated production process.

#### Current Status:

- A feasibility study was completed in 2020 which recommended the project be developed over three stages (6 GWh per stage) and demonstrated sound financial viability on a project basis with Net Present Value (NPV) of \$2.55 billion and 21% Investment Rate on Return (IRR).
- iM3TSV are negotiating with potential equity partners on the project and preparing the development application.

DriveIT NQ is a not for profit association, which incorporates local organisations, clubs, and individuals devoted to the establishment of Townsville's permanent driver education and motor sport precinct.

The DriveIT NQ precinct is the only regional owned motor sport facility within Australia and aims to be the prime multiple-purpose complex for organisational training, education and motor sport events.

#### Current Status

- DriveIT NQ lease 305.5 hectares and are constructing a purpose-built facility which will provide a safe environment for an array of motor sports including an international-standard speedway and drag track, a national standard circuit, and an off-road area.
- > Stage 1 of the development is complete with Stage 2 commencement of construction expected mid-2021.

## **EDIFY ENERGY** PROJECT HYPER

Two land parcels totalling 50 hectares is conditionally-committed to Edify Energy. The land parcels consists of:

I. 9.7 hectares for a future sub-station II. 41 hectares for a hydrogen facility

Edify Energy plan to provide affordable and sustainable electricity to Precinct users and into the electricity market.

The Majors Creek Solar Farm and battery storage project in Townsville is approved to generate 200 megawatts of power with direct access planned into the Ross-Strathmore (East) 275kv high voltage transmission lines. Located just 3.5km from the Lansdown Eco-Industrial Precinct, the solar farm is ideally placed to provide lowcost, locally-generated, behind-the-meter renewable energy to industrial users.

Edify Energy plan to also build an initial 10 MW hydrogen electrolyser pilot plant before scaling up development into commercial production with a 50 – 200 MW electrolyser facility.

The 2,200 hecters (ha) precinct provides access to the Great Northern Railway (connecting Port of Townsville to Mount Isa), Flinders Highway and Southern Port Access Road (including B-Triple capacity) is immediately adjacency to the North Queensland Gas Pipeline for future renewable hydrogen expansion, and future connection to Haughton Pipeline for provision of raw water supply to Industrial users.

Current proponents conditionally committed to Lansdown include:

- Imperium 3: \$3bn lithium battery manufacturing facility (186 ha)
- Pure Minerals: \$261m nickel coball processing facility (289 ha)
  - Edify Energy: \$400m 400mw integrated renewable energy plant (41 ha ± 9.7 ha)
  - DriveIT NQ 205.5 ha

Lansdown is an existing commitment under the Industry Powerhouse of the North Initiative of the TCD.

TCC is seeking \$50M for the construction of access roads, rail and water infrastructure and would like this considered for inclusion for Federal funding. If accepted, this commitment will give certainty to investors and facilitate the creation of advanced manufacturing jobs for the city and significant export revenue for the nation.

### Stadium Precinct

The Queensland Country Bank Stadium (QCBS) is a newly developed 25,000 seat stadium. It hosts major concerts and sporting matches, including football and national rugby league. The Stadium has become a showpiece of community lifestyle and is the source of surging investment in accommodation, entertainment and the public realm.





#### **Central Park**

# Townsville Eastern Access Rail Corridor (TEARC)

TEARC is a new 8.3 kilometre rail link connecting the North Coast Rail Line and Mount Isa Rail Line to the Port of Townsville through the State Development Area, removing freight trains out of the Townsville CBD and urban areas. This link will enable growth in rail freight volumes from the North West Minerals Province and growing agricultural precincts in Northern Australia.





### **Container Intermodal Terminal**

The Terminal will provide critical multi-user rail unloading and loading infrastructure. It will eliminate inefficiencies with modal change and double, even triple, handling of containers, generating an additional 45 FTEs in the region per annum.





## **Terminal Redevelopment**



Dear s47F and Prins,

Thank you for your informal engagement to date on the range of project proposals under consideration for the reallocation of the Australian Government's \$195m originally committed to the Haughton Pipeline Stage 2. Prins, thank you also for your recent written correspondence detailing Townsville City Council's position on many of these project proposals. You would both be aware that Minister Fletcher has been considering preliminary briefing on this issue. I'm pleased that I now have approval to engage with you formally on the reallocation options in the collaborative spirit of the Townsville City Deal.

The purpose of this email is to outline the Department's understanding of each of the project proposals to inform further constructive discussion, including ahead of the Executive Board workshop I have proposed to be held next month in either Townsville or Brisbane. The following is a summary of information gathered from a variety of sources, including Taskforce NQ, Townsville City Council (TCC), Phillip Thompson's Community Projects Advisory Committee (CPAC), and desktop research. I present this information on a 'without prejudice' basis, noting that the selection of projects will ultimately be decided in consultation with our leaders and, in our case, will require endorsement from the Prime Minister.

I understand you are already aware that the following seven projects were identified by the CPAC:





We understand \$50m is sought to construct access roads, rail and water infrastructure to support the development of the precinct. The proposal clearly aligns with the Deal, noting the existing commitment regarding the Woodstock intersection, but further clarity is needed on existing Queensland Government commitments towards an upgrade of the intersection and whether/how these commitments overlap with the funding sought by TCC.



I hope this perspective is useful in progressing an ongoing dialogue about the project options, and I welcome further feedback from either of you regarding the additional information I have suggested is needed. Of all the options

raised and under consideration, I note that the total funding amount required is significantly greater than the \$195m available for reallocation. We will need to consider the options in this context, noting that some of the projects may not be viable without additional funding and/or in-kind support.

I look forward to finding a suitable time for us to discuss the project options in person.
