You should already have much of the relevant information in relation to the site from prior discussions. By way of update, we are now in the process of implementing our 180 Ha biobank site in Cawdor.

The BODP (p172) outlines a number of criteria, in addition to value for money, that may be considered when confirming direct offset sites. The Cawdor Heights biobank, and credits derived from it, are a strong fit with these criteria:

- The site meets the condition criteria required to comprise the community as defined under the EPBC Act and associated policy (DEWHA 2010);
- While there are currently no known records of *Pimelea spicata* in the Cawdor Heights Biobank, there is suitable habitat, a potential seed bank source and with management actions funded and planned a high likelihood that the species will be detected on site in the future:
- The site contains habitat critical to survival, or essential habitat, for Grey Headed Flying-foxes;
- The site contains tree species identified as a commonly-used food source for the Swift Parrot, which is predicted to occur on site;
- The site possesses other biodiversity values appropriate to offset the airport's impacts on plants, animals and their habitats, such as the presence of the Cumberland Plain Land Snail and freshwater wetlands;
- The site is within the Cumberland IBRA sub-region and within 30km of the airport site:
- The site is within the CCC as an area identified as a "Core" Priority Investment Area, part of the Regional Corridor under the OEH *Cumberland Subregion Biodiversity Investment Opportunities Map* (previously known as Priority Conservation Lands by OEH), sits on a fourth order stream and, with neighbouring biobanks, protects over 300ha of contiguous CPW along Razorback Range at Cawdor. The restoration of these areas will reduce fragmentation and provide one of the largest patches of remnant CPW on the Cumberland Plain.

Further details relating to the Cawdor Heights biobank and its fit with these criteria are included as attachment A to this email.

Attachment A: Addressing the BODP direct offset site selection criteria for the *Cawdor Heights* biobank (Biobank 284):

The following sections address the ecological selection criteria for direct offset sites as outlined on page 172 of the Biodiversity Offset Delivery Plan, as they relate to the Cawdor Heights biobank (Biobank 284).

1. Presence of Cumberland Plain Woodland, linked to the credit types HN528, HN529 and HN512 (OEH 2018c)

Biobank 284 is dominated by Cumberland Plain Woodland. The registered NSW Biobank has available credits HN529. These credits have been verified by independent Biobanking Accredited Assessors \$ 47F and are registered with OEH (see OEH Register here).

These credits also meet the condition criteria required to comprise the community as defined under the EPBC Act and associated policy (DEWHA 2010).

2. Presence of occupied Pimelea spicata habitat.

While there are no known records of *Pimelea spicata* in Biobank 284, there is suitable habitat, a potential seed bank source and, with management actions as funded and planned, a high likelihood that the species will be detected on site in the future.

This judgement is based on the following:

Historical records of Pimelea spicata

Pimelea spicata is likely to have been relatively abundant across the Cumberland Plain prior to European settlement. It is difficult to accurately estimate current population size and extent of occurrence for *P. spicata* given that the species is cryptic and difficult to detect, particularly when not in flower, and may not be apparent aboveground during drought conditions such as we are experiencing currently.

There are several known populations in Camden (see Figure 1).

Seed bank

As outlined in the TSC Recovery plan (OEH 2007) a soil-stored seed bank may exist in areas where mature plants are no longer apparent. For example, Willis et al. (2003) found viable *P. spicata* seed beneath infestations of Bridal Creeper and African Olive where no mature *P. spicata* were apparent (Section 6.3). The *P. spicata* Recovery Plan (2007) concludes that estimates of above ground abundance may be a poor indicator of the potential abundance of *P. spicata* at a site.

Pimelea spicata can maintain a soil-stored seed bank. Willis et al. (2003) found that 'P. spicata seed bank appears to be about as extensive beneath infestations of Bridal Creeper and African Olive as it is in relatively weed free areas. As P. spicata has no obvious adaptations to aid seed dispersal, this result may suggest that extant individuals have been displaced from invaded habitats, leaving only the soil seed bank as evidence of their previous occurrence.' This information suggests that not only is the species capable of maintaining a long-lived persistent soil seed bank, but also that there may be populations in existence that are represented only by a soil stored seed bank.

Suitable Habitat

P. spicata is restricted to areas supporting, or that previously supported, the Cumberland Plain Woodland (CPW) vegetation community. *P. spicata* has been recorded in both Shale Hills and Shale Plains Woodlands. Biobank 284 contains both HN529 (Shale Hills Woodland) and HN528 (Shale Plains Woodland) and is currently dominated by African Olive.

Suitable Management

Germination from the soil-stored seed bank has been observed following fire, slashing/mowing, grazing and soil disturbance (NSW National Parks and Wildlife Service 1997; Willis et al. 2003; P. Hogbin pers. obs). These management measures are planned for Biobank 284.

3. Presence of habitat for the Grey-headed Flying-fox:

Biobank 284 contains foraging habitat critical to survival, or essential habitat, for Grey-Headed Flying-Foxes.

Based on the presence of known food trees and critical habitat criteria listed in recovery plans

Grey-Headed Flying-Foxes (GHFF) feed on blossom and fruit in canopy vegetation and forage over extensive areas. The Commonwealth's Draft Recovery Plan states that loss of foraging habitat is consistently identified as the primary threat to GHFF (Ratcliffe 1931, Tidemann et al. 1999, Dickman and Fleming 2002, Eby and Lunney 2002). Clearing of winter forage is a particular concern for the species.

The GHFF is a highly mobile, migratory species that relies on food sources with largely irregular patterns of production (Law et al. 2000). Patterns of occurrence and relative abundance within its distribution vary widely between seasons and between years. When assessed at a local scale, the species is generally present intermittently and irregularly (Eby and Lunney 2002).

The majority of myrtaceous plants in the diet of GHFF flower within a defined season but are not annually reliable, and the locations of productive foraging habitat provided by these plants vary (Law et al. 2000, Eby and Lunney 2002, Birt 2005). In most months it is not possible to predict what localities will be productive, and therefore what localities will provide essential habitat for the species. All foraging habitat has the potential to be productive during general food shortages and to therefore provide a resource critical to survival.

On the basis of current knowledge, foraging habitat that meets at least one of the following criteria can be explicitly identified as habitat critical to survival, or essential habitat, for GHFF. Biobank 284 meets at least two, and potentially all three, of these.

Natural foraging habitat that is productive during winter and spring, when food bottlenecks have been identified (ParryJones and Augee 1991, Eby et al. 1999).

Diet lists for GHFF include over 100 species of flowering trees and fleshy-fruited trees and lianas (ParryJones and Augee 1991, Eby 1995 and 1998, Hall and Richards 2000). All the tree species on Biobank 284 have been identified as food trees for GHFF. The two main tree species on site,

Eucalyptus cerebra (in all months except February) and *E. tereticornis* (from June until November) flower during the winter and spring bottleneck period and are listed as significant species for the GHFF (GHFF Recovery Plan - OEH 2018). Further:

- Eucalyptus cerebra flowers in all months but February.
- Eucalyptus tereticornis flowers in winter (June) until late spring (November).
- Eucalyptus moluccana the white flowers appear in mid-summer to mid-autumn.
- Angophora floribunda flowers appear from November to March.

These species are dominant on Biobank 284 as illustrated in **Table 1** (see overleaf).

Natural foraging habitat that is known to support populations of > 30 000 individuals within an area of 50 km radius (the maximum foraging distance of an adult)

Grey-headed Flying-foxes roost in large aggregations in the exposed branches of canopy trees (Ratcliffe 1931, Nelson 1965a, Parry-Jones and Augee 1992). The locations of camps are generally stable through time, and several sites have documented histories that exceed 100 years (Lunney and Moon 1997).

The Department of the Environment maintains records of known flying-fox camps. These locations have been used to produce maps of the modelled distribution for both Grey-headed and Spectacled Flying-foxes (*Pteropus conspicillatus*). A list and maps of known and historic Grey-headed Flying-fox camps are available from the department's website (DSEWPaC 2012g and example below in **Figure 2**). There are four camps within 13kms of Biobank 284 – well within maximum foraging range (50km) but also within known daily commutes to foraging areas, usually within 15 km of the day roost site (Tidemann 1998).

Natural foraging habitat that is productive during the final weeks of gestation, and during the weeks of birth, lactation and conception (September to May)

The two main tree species on site, *Eucalyptus cerebra* (in all months except February) and *E. tereticornis* (from June until November) flower during winter and spring. Other tree species on site flower during GHFF juvenile birth, lactation and conception periods.

Eucalyptus moluccana and Angophora floribunda, which both flower from in mid-summer to midautumn provide normal foraging habitat only.

4. Presence of habitat for the Swift Parrot

Biobank 284 contains tree species identified as a commonly-used food source for the Swift Parrot, which is predicted to occur on site.

Based on the presence of known food trees and critical habitat criteria listed in recovery plans

In Appendix C of BB284 - Biodiversity Assessment Report (Eco Logical Australia 2017), Swift Parrot is a species that was predicted to occur on site and is accounted for in ecosystem credits in accordance with the NSW BAM Methodology.

Based on the presence of known food tree species and critical habitat criteria listed in recovery plans for the species.




Figure 3: BioNet (NSW Atlas) records of Lathamus discolor near Camden

BB284 is contains large areas of lerp infested Grey Box *E. microcarpa*, a known food tree commonly used by Swift Parrots (OEH Recovery Plan). Further there are recent records within the locality (see **Figure 3**).

5. Presence of other biodiversity values appropriate to offset the airport's impacts on plants, animals and their habitats

Biobank 284 also supports:

- Cumberland Plain Land Snails (CPLS). Subject to removal of the African Olive, CPLS available habitat and resident populations on site are expected to increase.
- Approximately 1 hectare of freshwater wetlands are contained within BB284. While this credit type was not included as an ecosystem credit within the Biobanking agreement, the habitat present was assessed (by ELA and GHD) as HN630: *Phragmites australis* and *Typha orientalis* coastal freshwater wetlands of the Sydney Basin.






