# **Surf Sports**



10.2022.32.1

In the event of a noise or vibration problem arising, the person in charge of the premises must, when instructed by Kiama Municipal Council or the Accredited Certifier, cease work and carry out an acoustical survey and/or investigation by an appropriate acoustical engineer or consultant and submit the results to Council. The person in charge of the site must implement any or all of the recommendations of the consultant and any additional requirements of Council. Any requirements of Council in this regard must be complied with immediately.

#### (10) Noise - Construction

All works carried out on site during construction/ demolition/ excavation/ earthworks shall comply with the NSW Protection of the Environment Operations Act 1997, the Department of Environment and Climate Changes' Interim construction noise guideline' and AS 2436-2010 – "Guide to noise and vibration control on construction, demolition and maintenance sites" for the control of construction noise which specifies that:

- Construction period of 4 weeks and under The L90 level measured over a period of not less than 15 minutes when the construction site is operating must not exceed the background level by more than 20 dB(A) at the boundary.
- b) Construction period greater than 4 weeks but not exceeding 26 weeks The L90 level measured over a period of not less than 15 minutes when the construction site is operating must not exceed the background level by more than 10 dB(A) at the boundary.
- c) Construction period exceeding 26 weeks The L90 level measured over a period of not less than 15 minutes when the construction site is operating must not exceed the background level by more than 5 dB(A) at the boundary.

Should complaints of a noise nuisance be substantiated, Council may require the acoustic treatment of the premises to ensure compliance with the NSW Department of Environment and Climate Changes "Interim construction noise guideline" and AS 2436-2010 – "Guide to noise and vibration control on construction, demolition and maintenance sites" for the control of construction noise. A further acoustic assessment & report will be required to be provided to Council assessing the premises in working order.

#### **Property Management**

- (1) The Gerringong Surf Life Saving Club (GSLSC) is required to enter into a Deed of Agreement for lease with Council prior to the commencement of works.
- (2) The GSLSC is required to enter into a Construction Agreement with the building contractor appointed to undertake the internal fit out and Council prior to the commencement of works.
- (3) The GSLSC is required to enter into a Lease agreement for the use of the premises prior to taking possession and at practical completion of the building,
- (4) The GSLSC will not take possession or keys to the premises until such time as all agreements have been signed by all parties.

On behalf of Gerringong Surf Lifesaving Club Inc, please accept this response to your request for further information regarding Priority Community Infrastructure Program ( PCIP0031) in relation to Gerringong Surf Lifesaving Club — Clubhouse Redevelopment.

#### **Criterion 1**

• The extent to which your proposed project is a community priority, and meets the needs from an economic perspective.

The redevelopment of the Gerringong SLSC is an urgent community priority given the current facility is no longer fit for purpose. The current structure is rapidly failing and does not meet the needs of current members given the lack of storage and space for rescue facilities.

The Deloitte Report, commissioned in 2022, regarding *Social and economic value of Surf Life Saving Australia* demonstrates the social and economic impacts provided by surf clubs across Australia.

According to the report, for every \$1.00 spent on surf life saving, a return of \$20.20 is achieved for the Australian community.

Further to this, the total net benefit of surf life saving to the Australian community is anticipated to equate \$97 billion over the next 15 years. This figure is derived from both the social and economic benefits over this timeframe.

The actions of lifesavers across the Country, save over 1,300 lives annually and prevents a further 818 critical injuries. These lives saved and avoided injuries are valued at \$6.1 billion in present value terms.

SLSA provides CPR training to over 96,000 people each year who have not previously been trained in CPR. This training equips members and non-members to assist in medical emergencies in the community, saving an average of 294,855 hours of life each year.

In the past year Gerringong SLSC has trained over 50 local members in CPR and other life saving training, providing a huge social and economic benefit to the local area.

Gerringong members also provided over 4,000 man hours of patrol last season equating to 400 hours that the flags were up between September and the end of April.

Gerringong's economy relies heavily on tourism, meaning any injury or loss of life from a preventable incident at the beach would have the effect to cripple local business.

Socially, surf life saving plays an important role in the local community. The same report found that 67 percent of members are meeting the Australian guidelines for health benefits due to the high levels of physical activity required to partake in surf life saving.

Gerringong surf club provides physical training and programs for members including daily swimming, board and running training to ensure members can maintain an adequate level of fitness.

This improved fitness and mental well being provides major benefits for the local community and broader economy.

• The broader economic benefits your proposed project will deliver for the community and the region during and beyond the term of funding.

# Increase in jobs for the region:

During construction: The redevelopment project is expected to create more than 245 direct jobs. These jobs would include construction workers, project managers, architects, engineers, electricians, plumbers, carpenters, and other skilled tradespeople.

After construction: The completed project will create employment opportunities for six full-time roles and an estimated 40 casual roles through the kiosk, function room hire, and ancillary use. These roles would include positions related to function hire, chefs, bar staff, cleaning and maintenance.

#### New services or goods in the community created through the project:

The project will provide the community with state-of-the-art meeting rooms, a large-scale function space, and new public amenities.

The facility will have space for a permanent function room and/or restaurant, which would bring an increase in visitation and tourism to the local area.

# Indigenous economic participation and local supplier use:

The surf club has engaged in extensive consultation with the local Aboriginal community during the design and development process.

Local Aboriginal artists will be involved in designing components of the new clubhouse, including internal wall design and a screening wall on the southern boundary to the gym.

The club is committed to utilising Indigenous economic participation, including Indigenous employment and supplier-use outcomes, during the construction of the facility.

# Increase in efficiency of service delivery:

The construction of a state-of-the-art facility with improved amenities can indirectly contribute to increased efficiency in service delivery by providing a better-equipped and modern space for community activities.

# Evidence of consultation and economic benefits included in the process:

The surf club has undertaken a comprehensive community consultation process as part of the development application (DA) and design development phases. They have engaged with local residents, representatives from the local Aboriginal community, business owners, and various sections of Kiama Council.

The club is working closely with Kiama Council and the Office of Crown Lands through a pilot project, which includes an economic valuation of the old facility and strategic recommendations for the best use of the new club.

The program has brought on board a consultant firm to undertake an economic valuation of the old facility and will provide a strategic overview and recommendations on the best use of the new club moving forward.

The recommendations are expected to include options for the large-scale meeting rooms and function centre. The aim is to provide financial sustainability for the club and bring broader economic benefits to the wider community.

The outputs of this pilot program are expected to be delivered in August.

 According to the information provided you have advised that your organisation has sought funding from the NSW Government, however there is no supporting evidence on timeframes of this funding or documents supporting this funding. Can you please provide.

Copy of the signed agreement attached.

 According to the information provide you have advised that you have consulted with targeted stakeholders, local council, traditional landowners etc. Can you please provide more details and/or evidence on the consultation process and if there was any risks identified and how they have been mitigated.

In addition to the response above;

Public participation sessions were conducted as part of the DA assessment process. All stakeholders were notified of the development through the advertisement process and afforded the opportunity to provide both written or verbal representation during the determination of the application. Approximately 200 positive submissions were received supporting the project.

Feedback included aesthetic impact of the new building and acoustic considerations. Modifications to the design was undertaken to address feedback to the satisfaction of respondents and Kiama Council. Acoustic control measures were considered in a specialist Acoustic Consultant report for the use and operation of the facility.

 According to the information provided you have advised that project team consists of Council Project Managers and Engineers. There is some potential concern about a conflict of interest where development approvals etc need to go through council. Can you please advise how these concerns will be mitigated.

This is a misinterpretation or rather not clearly articulated in our application. The Gerringong Surf Club project team consist of surf club members that have current and previous experience on numerous civic projects with other councils; however, have not worked directly for Kiama Council. There are no current Project Managers or Engineers working for the surf club that are also employed by Kiama Council; therefore, no conflict of interest exists.

In your application you have advised that you are currently engaging with a local contractor in relation to this project and that you would like to continue with this local contractor. The department needs to be satisfied that due process has been undertaken to provide all business with the opportunity to tender for this project. Can you please advise how you will achieve this.

The local contractor that the club has been working with is a community minded construction company that satisfies local preference, they are the only commercial builder with operations based within the Kiama LGA. They are accredited suppliers to the NSW government for project valued between \$1M - \$9M and are member of the Master Builders Association with accredited ISO 9000 systems for quality, safety and

environmental. They have worked on a similar project with another Kiama LGA NFP to deliver a successful D&C project. Their early involvement on this project has had a significant impact on its current success.

There will be several controls implemented to ensure probity, value for money and equal opportunity for required trades and services.

- The club will prepare a tender evaluation plan (TEP) to assess the
  experience, expertise, systems, methodology and resources to deliver the
  project. We will ensure that their delivery program will meet the needs of
  the club and specified milestone dates within our funding agreements.
- The club will appoint an independent qualified accredited Quantity Surveyor (QS) to evaluate the tender cost proposal and breakdown of works. We will request the QS to seek an assessment of the contractors financial capacity to deliver the project and their risk of failure.
- The contractor will ensure that pricing requests for all sub-contract packages are sought from various local building trade and services providers. An assessment of costs, resourcing and ability to meet program will be considered prior to engagement.

The club is committed to working with local suppliers within the Kiama LGA to deliver this project.

As previously advised there is no current lease / licence agreement between Gerringong Surf Club and Kiama Council.

However, Kiama Council have imposed a relevant condition within the draft Development Consent conditions as follows.
