Brisbane 2032 Olympics and Paralympic Games delivered

The 2024–25 Budget provided a major investment in sport (\$494.2 million over two years), including record funding to support high performance athletes and para-athletes. Despite this, participation rates in sport and physical activity fall short of the level required to improve or maintain appropriate health outcomes for large sections of the community. Around 46% of Australian adults do not meet the Physical Activity Guidelines. Data also shows that while 90% of Australians have an interest in sport, only 40% participate in sport at least once a week.

Key updates

- The Office for Sport can work with your office in relation to media opportunities for **Play Our Way** grants, noting that 234 of 289 grants have been executed. The remainder are predominantly with applicants for consideration and acceptance, with a small number to be offered now the Caretaker period has ceased.
- **Sport Horizon:** the Office for Sport has engaged across Government to progress the ongoing implementation of Sport Horizon, including considering key metrics for success and highlighting the governments achievement of outcomes through sport.
- You have advised your preference for the Office for Sport to consider how it can continue to increase its **whole of portfolio approach** with a focus on stewardship. This, along with other opportunities such as reviewing where Government invests in sport to achieve outcomes (outside of the Sport Portfolio), sport diplomacy, and greater participation initiatives are areas for further exploration in support of your priorities.
