SMS to Triple Zero

- The Chair provided a summary/background of the SMS to Triple Zero issue and prompted members for their views on the subject.
- Telstra referenced its earlier proposal which had suggested a phased approach and that proceeding to the discovery phase, could be a useful next step.
- NECWG noted that the technology has moved on since the original SMS to Triple Zero proposal was submitted. NECWG noted that the original proposal was for SMS to triple zero, whereas developments in the messaging space have broadened such that SMS may not be the most suitable messaging platform to consider.
- One of the significant challenges with the original proposal was that it was pitched at whether it was technically feasible rather than whether it was operationally feasible, or desirable.
- The Chair noted the TZCC might retain the item on the agenda for future consideration and that the Department would consider a broader piece of work on the feasibility and desirability of a messaging to Triple Zero development.

- This would be a significant piece of work with implications for policy settings and numerous operational and legislative matters within each jurisdiction.
- It was also noted that there would likely be a significant budgetary impact to the jurisdictions from any decision to proceed with this work, and as such respective Ministerial consideration would likely be required.
- It was suggested that certain “at risk” groups may benefit from messaging services to triple zero, specifically those affected by deafness.
- The NRS representative advised that the National Relay Service, as well as being the Emergency Call Person for TTY-106 calling, provides various messaging options to contact emergency services

Meeting Minutes

Agenda Item 1 – Welcome

- The Chair welcomed all invitees to the meeting. The Chair noted that the Government is in caretaker period, limiting the department's ability to speak to the policy positions of a future government.

Agenda Item 3 – Triple Zero Custodian

- Kath Silleri gave a presentation on the background and status of the Triple Zero Custodian.
- Members asked a number of questions relating to the ultimate role of the Custodian, including what authority it would have to take actions on particular issues.
- The response to the questions, as outlined in the presentation, is that the role and legislative authority of the Custodian is a work in progress and further details will be available (likely to be available at our next meeting) once further briefing and decision are made at the Ministerial level.

Agenda Item 4 – Universal Outdoor Mobile Obligation (UOMO)

- Kath Silleri gave a brief summary of the department's activity in relation to the UOMO.
- The UOMO will allow D2D services in remote areas that are not served by terrestrial mobile - 'wherever you can see the sky'.
- The Minister has asked the department to explore being able to provide an expanded messaging access to Triple Zero.
- D2D has been operating in New Zealand for a while and they have found that the D2D service is also being used in urban areas which has been an interesting anecdote to come from their experience.
- Mobile operators are in conversation with some of our colleagues in the department. The department is in listening mode as we are in caretaker.
- Peter Sinclair noted the text capability limits that will need to be addressed.
- ^{s47F} asked if we will be ramping up our discussion of SMS to Triple Zero as he considers that it will need to be universal - that is, not just for D2D satellite.
- The department noted that it will be examining options and briefing the Minister following the election.

b. Emergency Plus App (Kath Silleri - DITRDCA)

- The department has been managing the maintenance and administration of the Emergency Plus App via a contract with 360 Entertainment, since April 2022.
- The department have recently extended the contract with 360 Entertainment through to April 2028.
- The department considers that it's now time to think about the purpose of the Emergency Plus App and whether it might be better placed outside the department for its future development, or whether it still serves a purpose.

- The department doesn't think it is something for the department to own, but it is still in use for the next three years given the contract extension. We will be seeking advice in the coming months.
- Peter Sinclair noted that in its current form there are doubts about its value, however, as we move to a new next generation triple zero service, it will need development. It could have some value in a brave new world but not currently.
- Sam Grunhard advised that the department will further consider if there is additional functionality to be pursued with the Emergency Plus App and inform members of any outcomes.


