1. A letter from a bipartisan coalition of 41 US Attorneys that was sent to Meta on 5 March regarding the need to address account hacking. A link to the official press release is also below:

While it doesn't mention fraud ads by name, it does mention using the hacked accounts to perpetuate scams on other users.

For a short read - paragraphs 1-17 are the fact summary and para 181-203 are an explanation of Jurisdictional arbitrage undertaken by Meta. This is what prevents regular Australian plaintiffs from being able to sue

I have also included two stories from earlier this year regarding Prime Minister Anthony Albanese's image being fraudulently used for a Facebook ad as well as the deep fakes that were created of Taylor Swift – demonstrating that Facebook and big tech companies can take down fraudulent ads, and fast
