- The Revive 2024 Annual Implementation Report ('the Report') (see Attachement A) was developed to fulfill the commitment in Revive to monitor and evaluate progress of the National Cultural Policy. This is the first of 3 reports to evaluate the impact of *Revive*. The next implementation reports will be developed and released (subject to your approval) in 2025 and 2026, which we anticipate will have more of an evaluation focus, as evaluations roll out.
- The Report highlights the key achievements of Revive from its launch in January 2023 to September 2024. This includes the:
 - a. establishment of Creative Australia on 24 August 2023.

- b. connection of arts to other government policies such as multicultural affairs, and employment conditions and support.
- c. completion of 58 out of 85 actions in *Revive* with 26 actions still to be delivered. Note that one action (the Uluru statement) has been marked as "no longer achievable."
- 3. The *Revive Annual Implementation Report 2024* identified early outcomes together with critical implementation enablers and barriers. The early outcomes were found to align with the ambitions of *Revive* and featured across all 5 pillars of *Revive*. These early outcomes are:
 - a. Centreing First Nations culture There has been increased inclusion within the arts sector of First Nations' perspectives, cultural protocols and safety in program and organisation plans.
 - b. Initiating innovation *Revive* has driven the establishment of new legislation, infrastructure and networks.
 - c. Strengthening trust in institutions Investment in the arts sector has brought about stability, transparency and sustainability.
 - d. Embedding equity Programs are more explicitly considering fair and equitable access for people from diverse cultural backgrounds, locations, socio-economic environments as well as for people with disability and the lesbian, gay, bisexual, transgender, queer and intersex community.
 - e. Enabling connections The whole-of-government focus of *Revive* has enabled and supported socio-cultural, technological and institutional connections across governments, sectors and communities.
- 4. Creative Australia has also produced its own implementation report on the *Revive* actions it is responsible for. Creative Australia's report (provided for information at **Attachment C**) reports on 20 actions, whereas the Office for the Arts counts and reports on 12 Creative Australia actions. The reason for this discrepancy is that Creative Australia has disaggregated some actions for evaluation purposes and has also reported on additional commitments in *Revive* not tracked by the Office for the Arts. As at 30 October 2024, Creative Australia has completed 6 action items out of a total of 12.
 - a. Significant achievements for Creative Australia under Revive include the transfer of Creative Partnerships Australia and the establishment of new bodies within Creative Australia for First Nations Arts, Music Australia and Creative Workplaces and the respective Board and Councils which have oversight of these areas. We have included a summary of Creative Australia's implementation report in the Report.

I am pleased to present to you the *Revive 2024 Annual Implementation Report* for your information. This report is being provided to all ministers who have actions in the National Cultural Policy, *Revive: a place for every story, a story for every place.*

Revive was released on 30 January 2023 and provides a broad and comprehensive five-year roadmap for Australia's arts and culture sector that touches on all areas of government, from cultural diplomacy in foreign affairs to health and education.

Revive has been a gamechanger for the creative sector in Australia and the Albanese Labor Government is providing more support for Australian artists to thrive and grow. The Report notes that after only 20 months, 68 per cent of the 85 actions in Revive have been delivered.
