#### **Key Points:**

- 1. On 23 August 2019 you confirmed a \$1.5 million commitment to Shed West Community Men's Shed Inc. (Shed West) towards the Kenmore Men's Shed Upgrade project.
- 2. Shed West has advised the Department of Infrastructure, Transport, Regional Development and Cities that the project will construct a new men's shed on land owned by the Brookfield Recreation Reserve Trust (Brookfield Showground) and also upgrade facilities at the grantee's current Council-owned site at 98 Brookfield Road, Kenmore Hills, Queensland.
- 3. Brisbane City Council has offered to take on the grant and use it to redevelop the 98 Brookfield Road site for the benefit of Shed West and two other tenants, the Kenmore Bridge Club and eWaste Connection.
- 4. The Council has advised that, as the owner of the land at 98 Brookfield Road, it is best placed to undertake the project and manage its planning, approvals and implementation.
- 5. The Department has been advised that Mr Julian Simmonds MP, Member for Ryan, is supportive of this change of grantee.

#### Financial impacts:

6. If you approve this request, there will be no change to the \$1.5 million (GST exclusive) funding contribution from the Australian Government.

#### Consultation:

- Brisbane City Council has advised that it has consulted with the three tenants of 98 Brookfield Road, Kenmore Hills.
- 8. No consultation or correspondence has been undertaken by the Department in relation to this matter, with Shed West.

#### Stakeholder Implications:

9. The Department understands that Shed West has been reluctant to accept Council's proposed management of this grant. Brisbane City Council will need to work with Shed West to develop a mutually acceptable project implementation plan should you agree to this change.
