### We work collaboratively with Member States to develop international standards and practices across all five Strategic Objectives of ICAO through:



## **Regional partnerships**

Australia fosters constructive partnerships throughout the Asia-Pacific region – with particular focus on our closest neighbours – and works to find pragmatic solutions on aviation safety and security and air navigation matters by:

- acknowledging national and regional aviation interests and priorities and focusing on strategic dialogue and information exchanges
- championing a strong and ongoing commitment to people-to-people links in aviation, including senior executive engagement and staff exchanges and secondments, as well as fostering bilateral industry linkages and regional dialogue
- promoting gender equity opportunities and diversity initiatives in the aviation sector

- supporting the Pacific Islands during the COVID-19 pandemic through our Sustainable Pacific Air Connectivity Program
- facilitating travel during the COVID-19 pandemic, including repatriating stranded Pacific Island nationals, and the movement of critical vaccines and other essential supplies
- cooperating closely with other Asia-Pacific regional states and global partners to achieve effective and sustainable aviation standards including supporting the Pacific Aviation Safety Office.



Australia administers **11%** of the world's airspace

### Australia has **31 designated** international airports,

in a network of over **300 aerodromes** supporting regular public transport, charter and general aviation traffic



Australia has one of the largest search and rescue regions in the world, covering **53 million** square kilometres, bordering the search and rescue regions of 10 other countries

Australia's domestic and international air freight is worth **one-fifth** of our total international trade value

There have been no fatal accidents involving civilian high capacity aircraft in Australia for nearly **50 years**

# We're committed to improving global aviation

### Air navigation capacity and efficiency

- promoting shared and harmonised civil-military airspace using a joint air traffic management (ATM) operating ruleset and a common fully integrated ATM system
- partnering with innovative technology companies sharing our expertise in ATM
- driving new capabilities to enhance the safety and efficiency for all airspace users.

### **Environmental protection**

- engaging and cooperating in ICAO's Committee on Aviation Environmental Protection
- providing expertise in developing policies and technical requirements that achieve better global environmental outcomes while facilitating countries' different stages of aviation development
- supporting the implementation of the Carbon Offsetting and Reduction Scheme for International Aviation (CORSIA), which aims to cap CO2 emissions from international aviation
- working constructively with other countries on the Long-term Aspirational Goal (LTAG).



### **Aviation safety**

- maintaining one of the most respected aviation safety systems globally
- supporting our State Safety Programme and meeting our ICAO Annex 19 commitments as one of the first countries in the world to publish a National Aviation Safety Plan
- working with other countries on return-to-service considerations and safe transport of vaccines during the COVID-19 pandemic as a safety partner in the Cooperative Development of Operational Safety and Continuing Airworthiness Programme South East Asia.

### Aviation security and facilitation

- working closely with international partners to develop and maintain effective aviation security practices, including delivering aviation security capacity building activities with our partners in the Asia-Pacific region
- transforming passenger facilitation by integrating digitallybased immigration and health systems, acknowledging that many countries will continue to rely on paper-based systems into the future.

# Post-COVID-19 response

As a vast island nation, Australia, like so many other States, experienced the devastating impacts of the COVID-19 pandemic on our tourism and trade industries. Post-COVID-19, Australia is looking ahead to recovery and a stronger aviation sector in the future.
