<b>Agenda Item 3: Technical Briefing – Airservices Australia</b>	<ul style="list-style-type: none"> <li>• Airservices Australia (Airservices) briefed the Forum on the next steps for the Post Implementation Review into changes to Brisbane airspace, including timeframes for community, industry and government engagement over the coming months.</li> <li>• The Forum discussed Airservices’ response to the final report on Trax International’s Independent Review of Brisbane New Parallel Runway Flight Paths Post Implementation Review, noting that Airservices had accepted all recommendations to progress further.</li> <li>• Airservices also provided an update on noise improvement trials and the announcement of a new trial to increase turboprop use of an RNP-AR flight path over Moreton Bay.</li> </ul>
