- ngayatham dhuka access informationgu (internet, radio, TV) ngunhiyi needed djarryunaraw decisionsgu mala.

Limurrka ngamangamayun **digital inclusion roadmap**. Roadmapdja plan ngunhiyi dhuka milkum ngatjandhu ngayatham goal.

Limurrunguny goal First Nations peoplegu mala ngayatham dhuka affordable ga reliable access phonelil, internetgu ga TV ga radio services marrka dhu enable walalany access informationlil mala ngunhiyi needed everyday walngaw.

Roadmap dhu gungayyun communitiesnha mala, governmentsnha mala ga industry rramabangiw djamat marrkadhu achieve Target 17 ga Outcome 17 ngunhiyi ga forms Governmentgu commitment under ngunhiyi National Agreement.

National Agreementdhuny ga ngayatham 17 targets mala. Target dhuny mala lika gungayyun governmentnha measure'w nhaltjan dhuka bulu manyakkum walnga First Nations peoplegu.

Target 17 dhuny ga lakaram yorrnha dhu 2026, Aboriginal ga Torres Strait Islander'w mala dhuka equal levels mala ngorra digital inclusiongu.

Target 17 dja ga relates Outcome 17lil, ngunhiyi ga ensuring First Nations peoplegu dhuka ngorra access information djarryunaraw decisionsgu mala walanggal walngangur ga communitiesngur.
