# ROVER guide: How add a RAV submitter to a vehicle type approval holder

## How to add a RAV submitter

Before you can authorise yourself or someone else to enter vehicles on the RAV on behalf of a company or individual you are acting for, the company or individual needs to be a vehicle type approval holder.

You also need <u>authority to act</u> on behalf of the company or individual. If you do not have an authority to act, you will need to <u>set one up</u>.

#### Step1

Sign in to <u>ROVER</u> and click on the authority to act icon at the top of the page.



#### Step 2

On the **Manage authority to act** page, go to the **My authorities** tab and select the company or individual you want to authorise yourself, or someone else, to be a RAV submitter for. This will open their **Account** page.

#### Step 3

When the company's Account page opens, select the RAV Submitters tab at the top of the page.

Step 5

Insert the details for whoever you want to add as a RAV submitter in the appropriate fields.

Note: The Email and Declaration fields are mandatory.

Read the declaration and tick the declarations box to agree to and sign the declaration.

Once you tick the **Declaration** box a blue **Add submitter** button will appear. Click the button to complete the process.
