The aircraft landed at 23:42 local time.

Circumstances Leading to Request: Qantas flight QF749 (Sydney to Adelaide) was delayed in the preceding sector (Adelaide to Sydney) due to engineering issues. This pushed the expected arrival time for the QF749 into the curfew period. A dispensation was granted for landing no later than 23:10 local time. QF749 had 87 passengers and 7 crew on board as well as 45L of perishable breast milk. The aircraft landed at 23:08 local time.
