Circumstances Leading to Request: Emirates flight EK414 (Dubai to Sydney) was delayed departing Dubai Airport due to needing to offload a sick passenger prior to take-off. EK414 had 459 passengers including 15 infants, 14 wheelchair passengers and 15 crew on-board. A dispensation was granted for landing no later than 11:30pm local time. The aircraft landed at 11:05pm local time.

Reasons for Approval: The Delegate was satisfied that exceptional circumstances existed for issue of a curfew dispensation.

EK414 had 469 passengers including 8 infants, 51 children and 11 wheelchair passengers and 28 crew on-board. EK414 also had 5 refrigerated units of pharmaceuticals on-board. A dispensation was granted for landing no later than 11:30pm local time. The aircraft landed at 11:15pm local time.

Circumstances Leading to Request: Qantas Airways QF748 (Adelaide to Sydney) was unable to land at Sydney Airport using the duty runway over the water due to storm activity in the area. A request to land over the city was made. A dispensation request was refused. The aircraft was diverted to Brisbane Airport.

Reasons for not granting Dispensation: The Delegate was not satisfied that exceptional circumstances were met.

Circumstances Leading to Request: Sri Lankan Airlines flight UL607 (Sydney to Colombo) was delayed on the previous sector out of Colombo. The airline attempted a quick turnaround of the aircraft upon its arrival however the aircraft was not ready for a departure before the curfew commenced. UL607 had 243 passengers, including 10 infants, 16 wheelchair passengers and 15 crew on-board. A request for dispensation was refused.
