



Key Discussion Items

Item 1 - Welcome, approval of agenda and draft meeting record (John Doherty, Chair)

The Chair welcomed attendees to the fifth meeting. NASAG approved the draft agenda and the record of the fourth meeting.

Progress on actions arising from previous meetings (refers document NASAG/5/1/3) is noted at Attachment A.

The Chair reminded NASAG that there had been a Freedom of Information (FOI) request which required the release of NASAG Minutes after consulting members. The Chair noted that DoIT would again consult members if required to comply with a request under FOI.

<u>Item 2 – Standing item: update regarding COAG/Cth/State & Territory processes with a bearing on NASAG (Scott Stone)</u>

Mr Stone (DoIT) advised that the role of NASAG will be raised at the next meeting of the Standing Committee on Transport (SCOT) to be held on 30 March 2011. It is expected that the role of NASAG will be explained to the Australian Transport Council (ATC) at the 20 May 2011 meeting prior to determining the need to go to COAG. Alternatively, it may be considered post-July 2011 by the new Transport and Infrastructure Council, given that the Planning and Local Ministers' Council will no longer exist.

Mr Stone said POG has been approached regarding the role of NASAG as agreed at NASAG 4 and a copy of the letter circulated to members.

Mr Stone said the COAG Cities reform process and the National Urban Policy development process were in progress. The aim is to ensure cities can meet future challenges by being more productive, sustainable, and liveable and better governed. It is envisaged that NASAG's work will be an input into the major cities planning work.



<u>Item 3 – Industry presentation – examples of safeguarding issues at Sunshine Coast</u> Airports (Simon Kinchington & Peter Pallot)

Mr Pallot and Mr Kinchington gave a presentation on land planning issues around Sunshine Coast Airports and the effect that residential development in the vicinity is having on their operations and expansion plans. In the case of Sunshine Coast Airport, buildings within the 20 ANEF contours had increased from one in the mid 1980s to 2,400 today. They stressed the need for better community understanding of aircraft noise impacts and the need to formalise the role of each of the government agencies so that it was clear to whom particular issues should be referred. They said that the problem was not RPT flights but circuit flying and suggested that tracking flight paths and using alternative noise metrics such as N60 and N70 would provide a better planning tool than the ANEF.

The Chair said that the pressure to use all available land should not be underestimated. Mr Stone commented that the time to take into account aircraft noise impacts is when rezoning is being considered. Once the decision to rezone had been taken it was probably too late to reject a proposal. Mr Murray (ACT) said ideally, it should be considered at the very outset, such as at the spatial planning stage.

<u>Item 4 – Presentation on the Moorabbin Airport Circuit Path Taskforce</u> (Marianne Richards, VIC)

Ms Richards (VIC) gave a presentation on this task force and its examination of the potential for changes to training circuits to improve safety and reduce noise. The task force was established as a condition of the Minister's approval of the Moorabbin Airport 2010 Master Plan. She suggested that the community impact could be dealt with in part by cooperation between the airport operator and aviation operators so that as far as possible flying circuits could be kept way from residential areas. However, as cities grew options to move circuits become more limited. Issues being examined include:

- · changes to hours/days of operation
- moving some training to non-urban airports
- using flight simulators to replace aircraft operations
- limiting total aircraft operations at the airport
- limiting number of aircraft in the circuit.

Ms Richards said that it was very important that people knew who to talk to about noise issues.

Mr Milln (SA) said that Parafield was a classic example of where the application of the ANEF system in isolation had produced bad outcomes with residential developments under training circuits.

Mr Kinchington (Sunshine Coast Airports) said that at Caloundra negotiations between operators, councils and residents had led to circuits being moved to over the airport and vacant land and as a result complaints had decreased.

Item 5 - DRAFT Guidelines: progress, issues and process to finalise:

The Australian Aviation Wildlife Hazards Group (AAWHG) was tasked in August 2010 by NASAG to develop guidelines to manage the risk of wild life strikes in the vicinity of airports.

A presentation was given by Mr Laurie Taylor, Chair, AAWHG and Manager, Engineering, of Qantas' Boeing 737 Fleet.

The guidelines propose benchmarks for distances to separate airports and attractants of potentially hazardous wildlife. The separation distances are based on ICAO-recommendations viz, 3km, 8km, and 13 km.

Mr Mathew (DoIT) gave a short presentation on draft guidelines on the following:

- protection of airspace
- wind turbines and wind turbine farms
- lighting and pilot distractions.

Mr Mathew explained that draft guidelines relating to building-generated wind effects were being finalised. The work is being conducted by a firm of wind-engineering consultants and a draft report is expected to be ready in time for the next NASAG meeting.

Mr Stone stressed that the guidelines are not supposed to be prescriptive, but rather their purpose is to build awareness and to assist local planners in making well informed decisions. It was agreed that the Secretariat will go through the guidelines to remove any language that is overly prescriptive, and members' comments will be considered prior to distributing revised guidelines within the next few weeks.

There was a general discussion about how the guidelines should be taken forward, with Mr Hrast (ALGA) suggesting that they be tested with those who would use them before they went out as final guidelines. This was agreed, although the Chair stressed that there may be instances where guidelines use established ICAO terminology and Australia should be reluctant to move away from this. It was also agreed that as far as possible it would be desirable to send out the draft guidelines for comment as a whole package.

Action item: NASAG5/1

- NASAG to provide comment on the following draft guidelines within two weeks:
 - Protection of airspace around airports
 - Wildlife hazard management
 - Wind turbine developments
 - Lighting/pilot distractions
- The Secretariat to redraft the guidelines as draft documents following receipt of NASAG comments and to circulate them to Members
- Members to consult on the draft guidelines within their jurisdictions, and ALGA is to consult with local councils,

Feedback from the consultations is due back to the Secretariat by 27 June 2011.

Item 6 - Consideration of Draft Principles Paper (Scott Stone)

Mr Stone said that the Secretariat had tried to change the tone of the draft principles to make them less prescriptive and therefore more likely to be acceptable to all jurisdictions. He said an implementation plan would be drawn up when the principles had been agreed.

DoIT recognised that each jurisdiction had its own land use planning arrangements and that they would be starting from different places. It was therefore important for each jurisdiction to be able to implement the principles in its own way. Mr Stone suggested that it would be useful to have a matrix which showed where the states and territories currently are and to use this as

the starting point for charting progress. He said that DoIT saw Queensland's state planning policy as progressive, especially on air space protection, but recognised that it might not work for others.

Members indicated broad acceptance of the draft principles, with some editorial changes. The only issue on which clarification was sought was the paragraph on responsibility for preparing planning documents that identify strategically important airports. The Chair said that the Government was keen to encourage the airports to accept that they had an important role to play in the process. He said that the Secretariat would have a look at this paragraph with a view to making it clearer.

Mr Stone said that in light of the response to the draft Principles Paper the Secretariat would start work on the implementation plan. The implementation plan will become more important with the Principles Paper becoming more aspirational and less detailed.

Action item:

NASAG5/2 The Secretariat to incorporate changes to Principles Paper and recirculate.

- The Secretariat to present a draft implementation plan for consideration at the next meeting.

<u>Item 7 – Table of existing legal/policy frameworks in jurisdictions to safeguard airports</u> (Dilip Mathew)

Due to lack of time, this item was taken on notice with comments to be referred to Dilip Mathew via the 'safeguarding' mailbox-safeguarding@infrastructure.gov.au.

Item 8 - Letter from Port Stephens Council (Andy Hrast, ALGA)

Mr Hrast (ALGA) explained the letter from Port Stephens Council. He said that the Council was not against Williamtown airport and were in fact very supportive. Their concern was the Joint Strike Fighter (JSF) which is noisier than the F18. The Council was keen to have a review of the ANEF system and AS2021 with reference to noise at military airports, specifically Williamtown.

Mr Kerwan (Defence) said that military airports have lower movement frequencies, but higher noise and more circuit flying than civil airports and the joint strike fighter was much noisier than the F18. The Chair commented that if the ANEF system were applied to military operations at Williamtown a much larger area and number of people would be affected. Mr Hrast said that the Council would like to attend a NASAG meeting to present their views. A particular concern they had was the impact on property values.

The Chair said that it was not NASAG's role to resolve particular issues and suggested that the Council be invited to write to him detailing their concerns and explaining what they saw as coming out of a review. NASAG would then put in place a process to work with Defence to address their concerns and report back to them on the outcome.

Action item:

NASAG5/3 ALGA to invite Port Stephens Council to contact the Chair detailing their concerns in relation to noise at military airports, specifically at RAAF base Williamtown.



<u>Item 9 – Any other business/concluding comments including next meeting and actions required (Chair)</u>

Next meeting

It was agreed the sixth meeting will held in Sydney or Melbourne in mid June 2011. The Secretariat will confirm venue and date.

Members expressed a preference that papers be staggered and requested that they be sent when ready rather than as a batch. Secretariat undertook to provide business papers three weeks before the meetings.

ALTERNATIVE AIRCRAFT NOISE METRICS

DEVELOPED BY:

Department of Infrastructure, and Transport (DOIT)

PURPOSE:

Discussion of alternative noise metrics that can be used to supplement the use of the Aircraft Noise Exposure Forecasts

(ANEF) for use in land use planning.

BACKGROUND

- 1. Over the past three decades the Australian Noise Exposure Forecast (ANEF) system has been used in four key ways. It is used to delineate where and what type of development can take place around airports; to determine which buildings have been eligible for insulation around Sydney and Adelaide airports; for technical assessments of airport operating options in Environmental Impact Statement (EIS) processes; and as a tool for providing information to the public on noise exposure patterns around airports.
- 2. Experience has shown a range of problems with relying solely on the ANEF to guide land-use planning decisions. Importantly, there are also significant limitations in using the ANEF as a way to describe aircraft noise exposure to laypeople.
- 3. While the populations with the highest aircraft noise exposure often live within the 20 ANEF contour, the majority of noise complaints that are received are now coming from residents living outside the 20 ANEF contour. Traditionally the residents of these areas have been given little information on aircraft noise through the ANEF system other than that the area is considered 'acceptable' for new housing. Some people living outside the 20 ANEF contour have been given an expectation of receiving little or indeed no aircraft noise and as a consequence find the levels of noise actually experienced to be unacceptable.
- 4. DOIT does not recommend replacing the ANEF system as a planning tool in the short-term. The ANEF system is a well–established and technically complete means of portraying aircraft noise exposure. However we believe land–use planning could be improved through recognition that aircraft noise does not suddenly stop at the 20 ANEF contour.
- 5. It is likely that no single standard will be appropriate for all airports but the concepts that follow can readily be adapted to meet local conditions. In particular, there may need to be recognition of the particular sensitivities of night—time noise in circumstances where neighbouring residents are not protected by airport curfews. The Australian Government and a number of state governments recognise the negative economic impact that could result from the imposition of additional airport curfews. There is a range of research pointing to the negative health impacts of sleep disturbance and the ANEF gives only limited recognition to the impact of night—time aircraft noise.

ALTERNATIVE MEASURES




Figure 1: 1998 aircraft noise complaints vs 1998 20 ANEI contour

6. Following the opening of the third runway at Sydney Airport in December 1994, it was recognised that the ANEF, while a useful tool for land—use planning, was deficient as a useful tool for describing information about aircraft noise to residents. Figure 1 shows the poor correlation between the 20 ANEI contour and the aircraft noise complaints in the Sydney area.

- 7. A range of alternative measures have been developed over the last 15 years to describe aircraft noise in a more meaningful way to affected residents. Some of these may have applicability to land—use planners.
- 8. One important piece of information frequently sought by members of the public when looking to purchase a house is often the location of the flight paths. DOIT, Airservices




Figure 2: 1998 jet flight path movements - Sydney

Australia and many airports have developed the use of flight path information over the last 15 years to provide a more meaningful summary of aircraft flight movements. Figure 2 illustrates this type of information for Sydney. However this information is of limited use in land—use planning decisions.




Figure 3: Single event contour

9. While aircraft flight paths are a useful way of presenting information on aircraft activity, they do not include information on the actual noise level of flights. Another useful way of presenting the impact of aircraft noise is to show the noise level of individual flight movements through the use of single event noise contours. Figure 3 shows an example of a single event contour for a Boeing 767–300 departing from Runway 34R on a particular track. It is possible to give an indication of how many of these flights will occur in a

typical day. However, it is also difficult to use the single event contour in a land-use planning context as separate diagrams are needed for each aircraft type and each track.

- 10. An approach that combines the information in a single event noise contour with the ability to consolidate this information into a description of high noise "zones" is available. This approach aggregates the individual N70 (or N65 or N60) events into a single graphic which describes the number of events within certain contours. Thus, residents can be informed in a way that is more intuitive, how many "noisy" events will be experienced within the illustrated zone. 70 dB(A) events have often been used to categorise an event as "noisy" as these can correspond to a 60 dB(A) noise level indoors, which can disturb conversation or other indoor activities such as watching television.





Figure 4: 1998 N70 - average day - Sydney

- 11. DOIT believes this concept can have direct applicability for land—use planning. Figure 4 shows a typical day N70 contour for Sydney Airport in 1998.

CASE STUDY OF THE APPLICABILITY OF THIS CONCEPT TO BRISBANE

12. DOIT has used the ultimate capacity model from the 2009 Brisbane Airport Master to model the effects of aircraft noise around the Brisbane Airport. The model provides an illustration which complements the ANEF modeling. Figures 5, 6, and 7 show respectively, the 20 event N70 contour, the 50 event N65 contour and the 100 event N60 contour. These measures recognise the variability in individuals' sensitivity to noise events. In particular, residents who value an outdoor lifestyle or those sensitive to sleep disturbing night—time noise events, may find the N60 measure more relevant to their concerns, and therefore useful for land—use planning purposes. The blue baseline area in each map represent the 20 ANEF contour, outside of which there are currently no land—use planning controls.



NIGHT TIME NOISE

13. The ANEF provides for weighting of night time noise events to take account of residents' increased sensitivity during evening and sleeping hours. Specifically, sound pressure

levels are increased by 6 dB(A) in the ANEF model for events between 7pm and 7am, effectively weighting them at four times the impact of daytime events. However, this can still under–represent the impact that a relatively small number of moderately noisy events can have during sleeping hours, as the AENF measures cumulative noise dose impacts rather than disturbance.

14. DOIT has illustrated the night time (10pm to 6am) impact at Brisbane using N60 contours, at the 3, 6 and 12 event levels, as illustrated in Figure 8.

National Airports Safeguarding Advisory Group (NASAG)

I am writing to you in your capacity as Chair of the Planning Officials Group (POG) to draw your attention to the role of the National Airports Safeguarding Advisory Group (NASAG). I chair NASAG and have undertaken to inform you of NASAG's work and investigate opportunities for future collaboration between POG and NASAG.

In December 2009, the Minister for Infrastructure and Transport, the Hon Anthony Albanese MP wrote to Premiers, Chief Ministers, Ministers for Planning and Ministers for Transport regarding the Australian Government's National Aviation Policy White Paper. Among other matters, the Minister advised them of the Government's intention to work with State, Territory and Local Governments and industry stakeholders on the establishment of a national land use planning regime near airports and under flight paths to minimise sensitive developments being constructed in areas affected by aircraft operations. The Minister sought constructive input from each jurisdiction on this important work.

NASAG was established last year to facilitate the delivery of this work through the development of a national framework to safeguard airports and communities around them from incompatible off-airport development (the Safeguarding Framework). The Safeguarding Framework will focus on off- airport land use planning for which States and Territories and Local Governments are responsible.


NASAG is an inter-jurisdictional forum representing State and Territory Planning and Transport Departments, the Australian Local Government Association, Department of Defence, Department of Infrastructure and Transport, Civil Aviation Safety Authority (CASA) and Airservices Australia. NASAG will develop the Safeguarding Framework and provide advice to Ministers on options to best implement such a framework within each jurisdiction's respective planning system.

Thank you for your letter of 10 March 2011 regarding the opportunity for future collaboration between the Planning Officials Group (POG) and the National Airports Safeguarding Advisory Group (NASAG) as a means of securing support from POG and Planning Ministers to progress the Safeguarding Framework.

In the past POG, on behalf of the State and Territory Planning Ministers, has been active in promoting a greater level of planning oversight of development at the major airports. POG agrees that the collaboration at a national level across aviation and land use planning interests would enable greater integration and positive outcomes for communities.

However you may be aware that the Ministerial Council structures under the COAG system are being rearranged and POG has not yet received advice on whether it will have a continuing formal role in that system.

With the future of POG yet to be clarified, there is however the opportunity for NASAG to form a working group with a membership of planning officials, including those NASAG representatives that are currently also POG members. Should NASAG form a working group, the POG Secretariat would be happy to assist in communications with the current POG members. Until POG's role is finalised in the national system, POG will be unable to take on any formal partnership arrangements as this time.

NATIONAL AIRPORTS SAFEGUARDING ADVISORY GROUP PROGRESS REPORT

PURPOSE

1. To provide a report on the work of the National Airports Safeguarding Advisory Group (NASAG) on a framework for safeguarding airports, in particular in relation to land use planning arrangements that better recognise aircraft safety requirements and noise impacts.

RECOMMENDATIONS

That TISOC

1. **NOTE** the progress report and ask that NASAG provide a package with recommendations for the consideration of the Standing Committee on Transport and Infrastructure by March 2012.

CONSULTATION AND LEVEL OF AGREEMENT

2. NASAG has developed a number of draft technical guidelines related to hazards such as birdstrike, wind turbines, lighting and penetration of operational airspace. These are currently being 'road tested' by local governments. Measures relating to use of additional metrics for assessment of aircraft noise impacts on land use planning are currently being developed and will require further consultation with airport operators and local governments prior to consideration by TISOC and SCOTI.

KEY ISSUES

Introduction

- 3. Increased demand for urban housing has placed planning pressures on many important transport corridors and pieces of critical infrastructure. COAG has agreed that the nine criteria for capital city strategic planning systems should include integration of land-use and transport planning and should provide for nationally-significant economic infrastructure (both new and upgrade of existing) including transport corridors, international gateways and intermodal connections. In relation to airports, flight paths need to be protected as well as the actual airport site.
- 4. Protection of the capacity for our major airports to operate safely and efficiently, both now and into the future, might be compromised by short-term development objectives, particularly where housing proposals are located in noise-affected areas close to airports and under major flight paths.
- 5. The Australian Government's National Aviation Policy White Paper proposed the development of a national land use planning framework that would:

use of supplementary noise metrics as a land use planning tool does not unnecessarily prevent urban infill developments needed to accommodate population growth and that legal certainty is maintained for development application assessments.

Next Steps

- 14. NASAG is working to identify the likely local impacts at respective airports in order to assess the potential application of alternative aircraft noise metrics. The Commonwealth is working with the leased federal airports to develop supplementary noise information to better inform NASAG's deliberations.
- 15. Once NASAG has considered this information, it is proposed that NASAG brings a package back to TISOC for subsequent consideration by SCOTI and then the Council Of Australian Governments (COAG). Once finalised, it is intended that these matters will be referenced in the COAG capital cities strategic planning review and also in implementing the Australian Government's National Urban Policy.

BACKGROUND

- 16. Population growth and urban infill are placing state and local governments under pressure to allow residential and commercial development close to airports and flight paths. This has the potential to constrain airport operations and expansion because of noise and public safety issues which arise from urban encroachment on airports, with flow—on negative economic impacts on the local, state and national economy.
- 17. The Aviation White Paper sought to address these issues by proposing working with state, territory and local governments and industry to develop a national airport safeguarding framework including a national land use planning regime to minimise sensitive developments around airports and to enhance noise management tools for land use planning and public information purposes.
- 18. The White Paper initiatives also included the development of guidance material for local planners to strengthen arrangements to protect airspace around airports (managing wildlife hazards, intrusions into protected airspace, wind turbine farms, lighting and other pilot distractions and building induced windshear).

TIMING

20. NASAG will consider supplementary noise corridor information provided by airports at its November 2011 meeting. It is anticipated that it will then provide a consolidated package of material on the safeguarding framework to TISOC in early 2012 prior to submitting the framework to SCOTI and COAG for endorsement in mid-2012.
