**IMPORT APPROVAL ISSUED UNDER REGULATION 15 - REGISTERED
AUTOMOTIVE WORKSHOP**

I approve the importation of the vehicle described in the Schedule below under regulation 15 of the Motor Vehicle Standards Regulations and section 20(1)(b) of the *Motor Vehicle Standards Act 1989* (the Act) on the condition that:

1. Unless otherwise authorised by the Administrator, a Used Import Plate must be affixed to the vehicle within 12 months of the date of this approval;
2. If condition 1 is not met the vehicle must be exported or destroyed within 30 days of the expiry of the 12 months in condition (1); and
3. The holder of this approval shall advise the Administrator in writing within 2 business days of the vehicle being exported or destroyed

and on the basis that I am satisfied that:

- i. the applicant is a registered automotive workshop; and
- ii. the vehicle was manufactured on or after 1 January 1989; and
- iii. the make and model of the vehicle is included in the schedule of approved vehicles for the applicant; and
- iv. the application to import was accompanied by an application for approval to place a used import plate on the vehicle; and
- v. for a vehicle other than a two-wheeled or three-wheeled vehicle — approval has not been granted to the applicant to import more than a total of 130 vehicles in the vehicle category to which the vehicle belongs in the period of 12 consecutive months immediately preceding the application; and
- vi. for a restricted volume two-wheeled or three-wheeled vehicle — approval has not been granted to the applicant to import more than a total of 130 vehicles in the vehicle category to which the vehicle belongs in the period of 12 consecutive months immediately preceding the application.

To contravene any of the above conditions could be an offence under subsection 20(3)(b) of the Act that may attract a penalty not exceeding 60 penalty units. To sell the vehicle or use it in transport in Australia before a Used Import Plate is affixed could be an offence under section 16 the Act that may attract a penalty not exceeding 120 penalty units.

Approval is given, under section 17A of the Act, for you to take delivery of the vehicle.

For the purpose of this approval "Used Import Plate" means a Used Import Plate approved by the Minister pursuant to section 13D of the Act.
