## Supporting broadcast coverage of under-represented sports

The Morrison Government has today announced \$10 million in funding to continue its support of coverage of women's, niche and other under-represented sports, bringing total funding for the under-represented sports grant to \$40 million over six years.

Minister for Communications, Cyber Safety and the Arts, the Hon Paul Fletcher MP, said the funding will allow Fox Sports to extend its broadcasting for under-represented sports over the next two years.

"With six dedicated sports channels and a wide range of sports news, Fox Sports has a strong commitment to broadcasting sports and events that may not otherwise receive television coverage," said Minister Fletcher.
