



B4(3) Foxtel needs to be notified of the Government's decision to enable the Department to commence negotiating a new funding agreement for the expanded program. A proposed response to Foxtel is provided at Attachment A.

2. Following the release of the COVID-19 media assistance package (15 April 2020), Mr Patrick Delany, the Chief Executive of the Foxtel Group (Foxtel) wrote to you (16 April 2020) requesting further assistance. In his letter at Attachment **B**, support 19 (3)

3. The Government is currently providing \$33 million to Foxtel from 2017–18 to 2020–21 to support television and online coverage of sports that receive low or no broadcast exposure. Under the current grant arrangement, Foxtel has received \$22.5 million.⁵³⁶⁴⁽³⁾

S34(3) Fox Sport has already publicly stated that it has achieved the milestone for a \$5 million payment under the current agreement so this payment should be acquitted first. The extra \$2.5 million would allow Foxtel to quickly invest in program capabilities

associated with the planned expansion of the program. This \$7.5 million payment in June exhausts the original funding envelope for the program. Two months after this payment is made (ie. end of August) Foxtel will be expected to lodge a plan proposing how it will spend the additional \$10 million in funding.

The Department will consult with the Department of Finance on revisions to the grant guidelines for this program and will then separately seek your approval for the Department to enter into a grant agreement with Fox Sports. A grant agreement is already in place with Fox Sports and this approval is necessary to vary the agreement to incorporate \$11 million (inc GST) in $\frac{83^{64}}{3}$

Grant guidelines

Although the funding is being provided as a one-off grant via direct offer to Fox Sports, the Department is required to prepare guidelines for all grant opportunities under the CGRG. The Department is required to consult with the Department of Finance on draft grant guidelines. Once this consultation has been completed, the draft guidelines must then be approved by you. A draft letter to the Minister for Finance will then be prepared which advises him that you have approved the grant guidelines. Although it is not mandatory to publish one-off grant guidelines on the Government's Grant Connect website, it may be appropriate to make them public in some form given the level of public scrutiny of this measure.

Selection of Fox Sports

As an element of the Broadcasting and Content Reform Package, announced in the 2017-18 Budget, the Government determined that it would provide a grant to Fox Sports to support the broadcast of underrepresented sports on subscription television, including women's and niche sports that receive low or no broadcasting exposure, and sports that command high levels of community involvement and participation.

This grant opportunity was established as a one-off grant. This is an appropriate type of selection process, as the nature of the grant activity is dependent on Fox Sports' expertise in sports coverage and broadcasting. Fox Sports' business model is well placed to enhance the levels of coverage of underrepresented sports, with expertise in developing and transmitting sports coverage through its linear and on-demand subscription television services. Fox Sports provides extensive and comprehensive coverage of domestic and international sports, including six dedicated sports channels and a wide range of sports news and reporting. This mix of sports extends to some lower-profile sports and events that receive little or no free-to-air television coverage. As such, Fox Sports is well-placed to use the funding to extend and develop the broadcasting of underrepresented sports.



Thank you for your letter dated 16 April 2020 concerning the impact of the COVID-19 pandemic on Foxtel's operations.


Foxtel is an important part of the media market and your business contributes to keeping Australians informed and entertained. I understand the challenges facing media businesses and how these have been exacerbated by the impacts of COVID-19.



Foxtel received a grant in the 2017-18 Federal Budget of \$30 million, payable over four years. To date, you have received \$22.5 million and I am pleased to note that Fox Sports is achieving all of its key performance indicators. I understand that last financial year alone, more than 5,850 hours of content was broadcast, including around 1,600 live hours.

Coming out of the COVID-19 pandemic the 43 different sport competitions that are benefitting from the funding are going to need more support to re-start their competitions. The Government is therefore willing to extend this grant program for a further 12 months with a further \$10 million investment in increasing coverage of women's, niche and under-represented sports.

Purpose:

1. In order to commit an early payment of \$2.5 million in funding to Fox Sports Australia Pty Ltd (Fox Sports) and to expand the total amount payable under the grant by a further \$10 million, your agreement to the proposed grant expenditure arrangement and amended funding guidelines is required.

3. On 4 June 2020 you wrote to Foxtel CEO Mr Patrick Delany offering to extend this grant program for a further 12 months with a further \$10 million investment in increasing coverage of women's, niche and under-represented sports. Fox Sports is owned and operated by Foxtel Group.

4. This has informed the development of amended program guidelines and allowed the Department to commence negotiating a new funding agreement for the expanded program with Foxtel. $^{S34(3)}$

The new milestones recognise that, coming out of the COVID-19 pandemic, the 36 different sport competitions that are benefitting from the funding this financial year need more support to re-start their competitions.

5. As per the Commonwealth Grants Rules and Guidelines (CGRC), the Department has prepared oneoff grant guidelines for the measure. The guidelines (**Attachment A**) require your approval.

6. A grant agreement is already in place with Fox Sports and this approval is necessary to vary the agreement to incorporate \$10 million (ex GST) in extra funding $^{S34(3)}$

The agreement has been prepared using the Commonwealth Low-Risk Grant Agreement Template, and a risk register has been prepared to support the use of this template.

Additional Information:

Your approval will increase expenditure to \$40 million (ex GST) of administered funding over the four financial years to 30 June 2023 to Fox Sports to support increased television and online coverage of under-represented sports. Under subsection 71(1) of the Public Governance, Performance and Accountability Act 2013 (PGPA Act), you may only approve a proposed expenditure of relevant money if you are satisfied after making reasonable inquiries that the expenditure would be a proper use of relevant money.

The Government is already committed to providing \$30 million (ex GST) to Fox Sports from 2017–18 to 2020–21 to support television and online coverage of sports that receive low or no broadcast exposure. Under the current grant arrangement, Fox Sports has received \$27.5 million, including a payment of \$5 million in June 2020 that was brought forward from August 2020. The final \$2.5 million to be paid early in FY20-21 will allow Fox Sports to invest in program capabilities associated with the planned expansion of the program. These \$7.5 million payments exhaust the original funding envelope for the program. By early September 2020, Fox Sports will be expected to lodge a plan proposing how it will spend the additional \$10 million in funding.

We also seek your approval for the Department to enter into a grant agreement with Fox Sports. A grant agreement is already in place with Fox Sports and this approval is to vary the agreement to incorporate \$10 million (ex GST) in extra funding that ERC agreed in May 2020 and extend the agreement to 30 June 2023. The agreement has been prepared using the Commonwealth Low-Risk Grant Agreement Template, and a risk register has been prepared to support the use of this template.

Grant guidelines

Although the funding is being provided as a one-off grant via direct offer to Fox Sports, the Department is required to prepare guidelines for all grant opportunities under the CGRG. The Department has consulted with the Department of Finance on the draft grant guidelines. Department of Finance are not required to approve guidelines for ad-hoc grants, they did however provide a range of comments on the draft.

In response to the comments from Finance, the Program Guidelines have been updated to incorporate more information on the grant assessment process, including the assessment criteria. Using the information that has now been provided by Fox Sports, this has facilitated a better assessment of the value for money that is expected to be delivered through the acquittal of this new grant funding.

Through the initial funding period for the grant Fox Sports has consistently delivered beyond the milestones in the current grant agreement. For instance, this past financial year, despite losing sport for the last quarter of the financial year due to COIVD-19, Fox Sports still broadcast more than 4,888 hours of content covered by the grant and 1,167 of these hours were broadcast live. This includes more than 3,053 hours of women's sport coverage which is a more than 100% increase since the baseline year before the grant – 2016-17. In each reporting period, the costs incurred by Fox Sports for the acquisition and broadcast of women's niche and emerging sports in 2019-20 have exceeded the grant allocation. This financial year, 36 different competitions have benefited and coverage of grant covered sports reached more than 3.69 million Australians.

Now that consultation with Finance has been completed, the draft guidelines (**Attachment A**) must then be approved by you. Although it is not mandatory to publish one-off grant guidelines on the Government's Grant Connect website, it may be appropriate to make them public in some form given the level of public scrutiny of this measure.

Selection of Fox Sports

As an element of the Broadcasting and Content Reform Package, announced in the 2017-18 Budget, the Government determined that it would provide a grant to Fox Sports to support the broadcast of underrepresented sports on subscription television, including women's and niche sports that receive low or no broadcasting exposure, and sports that command high levels of community involvement and participation.

This grant opportunity was established as a one-off grant. This is an appropriate type of selection process, as the nature of the grant activity is dependent on Fox Sports' expertise in sports coverage and broadcasting. Fox Sports' business model is well placed to enhance the levels of coverage of underrepresented sports, with expertise in developing and transmitting sports coverage through its linear and on-demand subscription television services. Fox Sports provides extensive and comprehensive coverage of domestic and international sports, including six dedicated sports channels and a wide range of sports news and reporting. This mix of sports extends to some lower-profile sports and events that receive little or no free-to-air television coverage. As such, Fox Sports is well-placed to use the funding to extend and develop the broadcasting of underrepresented sports.

Legislative authority

Schedule 1AB to the Financial Framework (Supplementary Powers) Regulations 1997 has been varied to establish the requisite legislative authority.

Section 32B of the FFSP Act provides legal authority for a grant as it is specified in an item at Schedule 1 to the Financial Framework (Supplementary Powers) Regulations 1997 (FFSP Regulation). For the proposed grant, the relevant item is 245 (Television Coverage for Women's Sport and Niche Sport).

Under subsection 71(1) of the PGPA Act, you may only approve a proposed expenditure of money if you are satisfied, after making reasonable enquiries, that the expenditure would be a proper use of relevant money. You may approve proposed expenditure to the proposed grant recipients set out at Attachment A if you are satisfied that this is the case.

In addition to the above mentioned requirement, under the CGRGs, you:

- a. must not approve the grants without receiving written advice from the Department on the merits of the proposed grant relative to the Guidelines and the key principal of achieving value for money. This minute constitutes the Department's advice in this respect; and
- b. record, in writing, the basis for the approvals relative to the Guidelines and the key principle of achieving value for money. Your signing of this minute and approval of the particular grant recommendation, as manifest on page 1 of the recommendations section of this minute, once completed, will form the written record of your approval.

1. Funding to support television and online coverage of under-represented sports: overview and objectives

The objective of the grant opportunity is to support television and online coverage of underrepresented sports, including women's sports, niche sports and emerging sports that exhibit high levels of community involvement and participation.

This funding was first announced in the 2017-18 Budget on 6 May 2017, as an element of the Broadcasting and Content Reform Package. The first tranche of funding of \$30 million was for the four financial years to 30 June 2021.

In June 2020, an additional \$10 million was added to the grant to accelerate program outcomes and expand the program through to June 2023.

The expected outcome of the grant activity is increased television and online coverage of under-represented sports, including women's sports, niche sports, and emerging sports that exhibit high levels of community involvement and participation.

Secondary or ancillary benefits expected to flow from the grant include the following:

- an increase in the ability for women's, niche and emerging sports to grow participation, levels of community engagement, and their fan bases;
- an increase in the ability for women's sports, niche sports and emerging sports to commercialise their content; and
- providing an opportunity to establish role models and pathways for aspiring athletes in the community, particularly young women.

The grant will be undertaken in accordance with the *Commonwealth Grants Rules and Guidelines (CGRGs)* <u>https://www.finance.gov.au/government/commonwealth-grants/commonwealth-grants-rules-guidelines</u>

2. Grant selection process

This grant opportunity has been established as a one-off or ad hoc grant. The Government considers that this is an appropriate type of selection process considering the nature of the granting activity is specifically dependent on Fox Sports' expertise in sports coverage and broadcasting.

Fox Sports was selected for direct offer as its business model is well placed to enhance the levels of coverage of under-represented sports, with expertise in developing and transmitting sports coverage through its linear and on-demand subscription television services.

Fox Sports provides extensive and comprehensive coverage of domestic and international sports, including six dedicated sports channels and a wide range of sports news and reporting. This mix of sports extends to some lower-profile sports and events that receive

little or no free-to-air television coverage. As such, Fox Sports is well-placed to use the funding to extend and develop the media coverage of women's and niche sports.

The Fox Sports proposal will need to effectively address the following four criteria for the program:

A. <u>Demonstrated understanding of the need for the funded activity for each identified target</u> <u>sport.</u>

Fox Sports will need to identify and demonstrate an awareness of the specific needs of the target sports and provide evidence about the needs of each sport. It will need to provide evidence that each sport has high participation rates or anticipates high growth in emerging needs; is identified as a priority area and has poor access to media coverage today. Fox Sports will need to demonstrate strategies to respond to the emerging needs in the target sports such as flexible service provision, collaboration and linkages with other organisations and service providers and demonstrate how the service will benefit each target sport and community including intended benefits and evidence to support the service approach.

B. <u>Description of how the implementation of the program will achieve the activity objectives</u> for all stakeholders, including value for money within the grant funding.

Fox Sports will need to demonstrate a clear understanding of the activity's objectives and support this with evidence. It will need to provide a clear and detailed description of how the program will be implemented, including evidence of how the program will achieve value for money. It must specify the linkages between proposed outcomes and projected deliverables, the benefit to the target sports and their communities and the amount of funding sought. It must identify strategies to demonstrate how the program objectives will be met; describe how the program will complement existing services and resources within the community and described links with the community and target sports including established relationships with stakeholders, relevant organisations, clients, and other service providers.

C. <u>Demonstrated experience in effectively developing, delivering, managing and monitoring</u> <u>similar initiatives to give confidence it will achieve program objectives for all stakeholders</u>.

Fox Sports will need to clearly define the way in which it will plan, develop, deliver, manage and monitor the program. It will need to demonstrate its experience in establishing and delivering similar types of services. It must demonstrate an understanding of the proposed outcomes of the program and how it will establish and maintain services in the identified sports. It should outline its stakeholder engagement and relationship management processes to ensure effective delivery of the program. Evidence of how it will engage with the community when planning and delivering services will need to be provided and there will need to be clear strategies for how it will provide ongoing assessment to ensure it meets the identified outcomes including the use of key performance indicators and reporting arrangements. D. <u>Demonstrated capacity and capability to deliver the program objectives in the identified</u> sports and their wider communities.

Fox Sports will need to demonstrate relevant expertise, skills, qualifications and experience in its executive and for those that will be involved in the management and delivery of services. It will need to outline the governance arrangements for the program and demonstrate that governance principles and processes to support service delivery are in place across all aspects of the organisation. Descriptions of relevant expertise, skills, qualifications and experience, including broad structure of the organisation, as well as business management, relevant expertise and leadership will be required. Fox Sports will need to demonstrate how the expertise, skills, qualifications and experience will contribute to the effective and efficient delivery of the program and the continuous improvement and evaluation of the day-to-day management of the program.

3. Who will approve the grant?

The Minister for Communications, Cyber Safety and the Arts will make the final decision to approve a grant.

The Minister's decision is final in all matters, including:

- the approval of the grant;
- the grant funding amount to be awarded; and
- the terms and conditions of the grant.

The Minister must not approve funding if they reasonably consider the program funding available across financial years will not accommodate the funding offer, and/or if the commitment does not represent value for money.

There is no appeal mechanism for decisions to approve or not approve a grant.

4. The grant agreement

The funding recipient must enter into a legally binding grant agreement with the Commonwealth represented by the Department of Infrastructure, Transport, Regional Development and Communications. The Department will use the *Commonwealth Low-Risk Grant Agreement Template*. Standard terms and conditions for the grant agreement will apply and cannot be changed. A schedule may be used to outline the specific grant requirements. Any additional conditions attached to the grant will be identified in the grant offer or during the grant agreement negotiations.

The successful applicant will be required to:

• provide a Strategic Roadmap (work plan) each year for agreement with the Department;

- provide performance reports against the Strategic Roadmap for each relevant year of the agreement and for the full term of the grant;
- provide statements to certify that the funding has been acquitted in accordance with the grant agreement and Strategic Roadmap for each relevant year of the agreement; and
- audited financial statements for the full term of the grant.

The Department will negotiate an agreement with the Grantee. This original grant agreement was finalised in December 2017 and the variation to the agreement is expected to be finalised in June 2020.

Where a grantee fails to meet the obligations of the grant agreement, the relevant Commonwealth entity may terminate the agreement and recover funding as per the grant agreement.

Financial commitments should not be made until a grant agreement has been executed by the Commonwealth.

5. Announcement of grants

Grants awarded will be listed on the GrantConnect website 14 days after the date of effect as required by Section 5.3 of the *CGRGs*.

6. Grant acquittal and reporting

The grantee must submit reports in line with the timeframes in the grant agreement. Reports will include:

- A Performance Report against the Strategic Roadmap for each year of the agreement and for the full term of the grant; and
- statements that certify that grant money received during the relevant financial year has been spent for the purposes of the objective and in accordance with the grant agreement and the relevant Strategic Roadmap; and
- audited financial statements for the full term of the grant.

The grantee will also be responsible for:

- meeting the terms and conditions of the grant agreement and managing the activity efficiently and effectively; and
- complying with record keeping, reporting and acquittal requirements as set out in the grant agreement.

7. Grant evaluation

The Department will evaluate the grant program to measure how well the outcomes and objectives have been achieved. The grant agreement requires the grantee to provide information through performance reporting to help with this evaluation.
