Thank you for accepting Minister McVeigh's extension of your appointment to the Business Members Group of the Joint Commonwealth and Tasmanian Economic Council.

I called your office this afternoon to make contact with you on a couple of matters.

First of all, I would like to ask whether you could complete and send back the appointments papers for the extension of your appointment to the Business Members Group advising the Joint Commonwealth and Tasmanian Economic Council. The papers were sent to you on 6 July (as per the email below) but I am resending them in case they went astray. The completion of these papers is necessary for your appointment to be completed.
