On 3 March 2020, the shareholders of the Australian Associated Press (AAP) announced that the AAP Newswire would close. The AAP Newswire business was acquired by a new consortium on 4 August 2020. The consortium has provided a limited lifeline to allow the business to restructure and work towards financial sustainability. While this sale has now taken place, the challenge is to make sure that AAP Newswire remains in operation to continue providing high quality public interest journalism to Australian media outlets, particularly those servicing regional Australia.



The Australian Government has allocated a total of \$55 million (GST exclusive) in grants under the Public Interest News Gathering Program (PING) to support the provision of public interest journalism in regional Australia. The objective of the PING Program is to support regional broadcasters and publishers to maintain or increase their production and distribution of public interest journalism in regional Australia during the COVID-19 pandemic phase.

On 29 June 2020, the Minister for Communications, Cyber Safety and the Arts, the Hon Paul Fletcher MP, announced that 107 regional broadcasters and publishers would share in \$50 million (GST exclusive) under the first stream of the PING Program. Grantees are required to enter into agreements with the Department of Infrastructure, Transport, Regional Development and Communications (on behalf of the Commonwealth) and grant information will be published on GrantConnect within 21 days of agreements being executed.

Given the significant economic disruption to the entire media and broadcasting sector arising from the COVID-19 pandemic, an additional \$5 million (GST exclusive) of funding has been made available under the PING Program to provide support to major media businesses who were ineligible to apply for funding under the first stream of the PING Program.

To be found eligible to receive funding under the original PING Program, media outlets had to fall into one of the following categories

- Stream funding pool 1: Regional Television Broadcasters
- Stream funding pool 2: Regional Radio Broadcasters
- Stream funding pool 3: Regional Publishers

AAP Newswire would not have been found eligible to receive funding under the original PING Program as, while they may be considered to be a distributor of public interest journalism as they provide news content to other media outlets, for the purposes of the original PING Program, they would not have been considered to be a regional publisher and as such, would not have met the eligibility criteria set out in the original PING Program Guidelines.

Consistent with the PING Program, AAP will be required to maintain or increase their level of public interest journalism in regional areas. AAP will achieve this in two major ways:

- providing direct support in regional news gathering via funding of local journalists; and
- providing critical indirect support through provision of newswire services to regional publishers which allows them to focus on their own investment solely on local reporting.

This will be achieved in the following ways:

<u>Production and distribution of public interest journalism through maintenance of regional bureaus</u>

AAP recently had to close its Darwin, Cairns and Townsville Bureaus. These closures mean that Far North Queensland and Australia's top end have lost a critical source of media

coverage for the area. Funding will allow AAP to reopen these bureaus and cover the salaries and technology required to operate these bureaus.

<u>Production and distribution of public interest journalism in regional areas through freelance</u> arrangements

AAP has traditionally had an extensive network of freelance journalists providing coverage of and to regional areas. The model provides numerous benefits to both AAP and the wider media industry including providing regional employment opportunities for local journalists, promoting regional Australian communities to a wider audience and providing coverage of news and events to Australian regional audiences. This content is distributed into regional areas as part of the supply of the AAP Newswire to AAP's regional customer base, which comprises 259 mastheads.

AAP had to scale back the use of regional freelancers. Funding will be used to support the use of regional journalism freelancers to increase the production of public interest journalism in regional areas. This amount includes part of the producers, editors and planners time required to effectively manage the freelancers' content to ensure it meets the AAP quality.

### 3. Who will approve the grant?

The Minister for Communications, Cyber Safety and the Arts will make the final decision to approve a grant.

The Minister's decision is final in all matters, including:

- the approval of the grant;
- · the grant funding amount to be awarded; and
- the terms and conditions of the grant.

The Minister must not approve funding if he reasonably considers the program funding available will not accommodate the funding offer, and/or if the commitment does not represent value for money.

There is no appeal mechanism for decisions to approve or not approve a grant.

### 4. The grant agreement

The funding recipient must enter into a legally binding grant agreement with the Commonwealth represented by the Department of Infrastructure, Transport, Regional Development and Communications (the Department). Consistent with the first stream of the PING Program, the Department will use the *Commonwealth Low-Risk Grant Agreement Template*. Standard terms and conditions for the grant agreement will apply and cannot be changed. A schedule may be used to outline the specific grant requirements. Any additional conditions attached to the grant will be identified in the grant offer or during the grant agreement negotiations.

Consistent with the objective of the PING Program, the grantee will be required to maintain or increase the production and distribution of public interest journalism in regional areas during the grant period (12 months from the date of execution of the grant agreement). The Department will request information from the Grantee, which will include the following:

- details of the activities, budget and timings relating to the expenditure of funds to meet the objective of the PING Program and conditions in the grant agreement;
- six and 12-monthly reports against the stated activities, budget and timings;
- statements to certify that the funding has been acquitted in accordance with the grant agreement (as requested by the Department);
- certified financial or other statements for the full term of the grant (as requested by the Department).
- any supporting information as requested by the Department.

The Department will negotiate an agreement with the grantee. The grant agreement is expected to be finalised by September 2020.

Where a grantee fails to meet the obligations of the grant agreement, the Department may terminate the agreement and recover funding as per the grant agreement. Financial commitments should not be made until a grant agreement has been executed by the Department on behalf of the Commonwealth.

### 5. Announcement of grants

Grants awarded will be listed on the GrantConnect website not later than 21 calendar days after the date of effect as required by Section 5.3 of the Commonwealth Grants Rules and Guidelines 2017.

### 6. Grant acquittal and reporting

The grantee must submit reports consistent with the requirements of the PING Program, with obligations detailed in the executed grant agreement. Reports will include:

- six and 12-monthly reports against the grantee's stated activities, budget and timings in the grant agreement;
- financial or other statements as requested by the Department that certify that grant money received during the grant period has been spent for the purposes of the objective and in accordance with conditions in the grant agreement; and
- any supporting information requested by the Department.

The grantee will also be responsible for:

 meeting the terms and conditions of the grant agreement and managing the activity efficiently and effectively; and • complying with record keeping, reporting and acquittal requirements as set out in the grant agreement.

### 7. Grant evaluation

The Department will evaluate the grant program to measure how well the outcomes and objectives have been achieved. The grant agreement requires the grantee to provide information through performance reporting to help with this evaluation.

On 3 March 2020, the shareholders of the Australian Associated Press (AAP) announced that the AAP Newswire would close. The AAP Newswire business was acquired by a new consortium on 4 August 2020. The consortium has provided a limited lifeline to allow the business to restructure and work towards financial sustainability. While this sale has now taken place, the challenge is to make sure that AAP Newswire remains in operation to continue providing high quality public interest journalism to Australian media outlets, particularly those servicing regional Australia.

AAP Newswire currently services over 100 regional and community news outlets who in turn serve a large majority of regional Australia. The Newswire provides these regional outlets with core public interest content focused on national, state and regional level news. AAP is an essential piece of media infrastructure and will help Australian regional mastheads to reduce the costs of producing public interest journalism.


All content produced and distributed by AAP constitutes public interest journalism as it seeks to inform and engage the general public at a local, regional and national level about important issues. AAP's reporting, covering courts, federal and state politics, breaking news, economics, sport and world news, is fact-based reporting by skilled journalists covering matters that are of importance to the people of Australia. AAP Newswire is a key source of public information for many Australians, including, most relevantly, its regional customers and their audiences.

Consistent with the PING Program, AAP will be required to maintain or increase their level of public interest journalism in regional areas. AAP will achieve this in two major ways:

- providing direct support in regional news gathering via funding of local journalists; and
- providing critical indirect support through provision of newswire services to regional publishers which allows them to focus on their own investment solely on local reporting.

Funding AAP Newswire would be consistent with the objective of the PING Program to support regional journalism. The proposed funding amount to AAP would be similar in size to grants provided to large media entities under the first stream of the PING program.

Funding awarded under the PING Program is considered to be a grant for the purposes of the Commonwealth Grants Rules and Guidelines 2017. The Commonwealth Grants Rules and Guidelines 2017 establish the overarching Commonwealth grants policy framework in relation to the administration of grants.

As the decision-maker under the PING Program, you are required to comply with the obligations set out in the CGRGs, the PGPA Act, and the *Public Governance*, *Performance and Accountability Rule 2014* (PGPA Rule). For example, the PGPA Rule requires that where accountable authorities or officials approve a proposed commitment of relevant money, the approval must be recorded in writing as soon as practicable after the approval is given.





### Talking points for discussion with AAP regarding their financial position

- As you are aware, the Minister announced on 18 September that the Government would provide \$5 million in funding to AAP under the Public Interest News Gathering (PING) Program to support public interest journalism in regional areas.
- The PING Program is designed to support media organisations to maintain or increase their production and distribution of public interest journalism in regional communities during the COVID-19 pandemic.
- The Commonwealth Grant Rules and Guidelines 2017 (CGRGs) and Public Governance, Performance and Accountability Act 2013 (PGPA Act) require that a Minister <u>must not</u> approve proposed expenditure of relevant money unless satisfied, after reasonable inquiries, that the expenditure would be a 'proper' use of relevant money (value for money). 'Proper' when used in relation to the use or management of public resources means efficient, effective, economical and ethical.
- Applicants under the original PING Program were required to certify that their organisation was solvent at the time of application. Applicants were required to provide financial statements (e.g. profit and loss statement) which was certified by the CFO or a registered Chartered Accountant. Certification was in the form of a Statutory Declaration which indicated that the organisation was solvent as evidenced by the accompanying financial documentation.
- The \$5 million funding is a one off grant and is designed to provide short term relief only. It is not expected to be annual grant program.
- For the Minister to approve the release of funds to AAP, the Department needs to seek information on the financial status of AAP. Information sought includes:
  - o Solvency status and certified financial statements (profit/loss statement; statutory declaration signed by CFO/ Chartered Accountant).
  - o Status of contracts with major regional media outlets including Australian Community Media and SevenWest including length of contracts.
  - o Status and number of contracts with other broadcasters and publishers.
  - O Strategies to make AAP a viable business in the longer term, including plans to attract new customer/ retain current customers.
  - o Aadditional investment opportunities being sought to support AAP's long-term sustainability
  - o Proposed expenditure and activities to fund using the \$5 million grant (can be based on AAP's earlier proposal provided to the Department e.g. proposed Darwin, Cairns and Townsville Bureaus).
- The Department to provide AAP with a joint application / grant activities and expenditure form that will request the information above.
- This approach is two-pronged it will allow the Department to collect documentation regarding solvency as per the application process under the original funding stream. It will also set a benchmark for reporting purposes and allow us to ensure that the suggested activities are in line with the objectives of the PING Program.



## **Public Interest News Gathering Program**

The Australian Government has allocated a total of \$55 million (GST exclusive) in grants under the Public Interest News Gathering Program (PING) to support the provision of public interest journalism in regional Australia. The objective of the PING Program is to support regional broadcasters and publishers to maintain or increase their production and distribution of public interest journalism in regional Australia during the COVID-19 pandemic phase.

On 29 June 2020, the Minister for Communications, Cyber Safety and the Arts, the Hon Paul Fletcher MP, announced that 107 regional broadcasters and publishers would share in \$50 million (GST exclusive) under the first stream of the PING Program. Grantees are required to enter into agreements with the Department of Infrastructure, Transport, Regional Development and Communications (on behalf of the Commonwealth) and grant information will be published on GrantConnect within 21 days of agreements being executed.

Given the significant economic disruption to the entire media and broadcasting sector arising from the COVID-19 pandemic, an additional \$5 million (GST exclusive) of funding has been made available under the PING Program to provide support to major media businesses who were ineligible to apply for funding under the first stream of the PING Program.

The Australian Associated Press (AAP) Newswire will receive \$5 million (GST exclusive) of the additional funding to support its news services into regional Australia.

Consistent with the objective of the PING Program, the expected outcome of this grant will support AAP Newswire to maintain its production and distribution of public internet journalism in regional areas during the COVID-19 pandemic phase. A secondary benefit will enable AAP Newswire to continue to provide a vital service to regional media outlets that rely on AAP Newswire for breaking, national and regional news.

The grant will be undertaken in accordance with the Commonwealth Grants Rules and Guidelines 2017.



#### **Additional Information:**

#### PING Program

On 29 June 2020, you announced that 107 regional broadcasters and publishers would share in \$50 million (GST exclusive) under the first stream of the PING Program. Of the 107 grantees, five are regional television broadcasters; 13 regional radio broadcasters; and 92 regional publishers. As at 20 August 2020, 86 funding agreements have been executed. Grantee details are published on GrantConnect within 21 days of agreements being executed. The objective of the PING Program is to support regional broadcasters and publishers to maintain or increase their production and distribution of public interest journalism in regional Australia during the COVID-19 pandemic phase.

AAP Newswire would not have been found eligible to receive funding under the original PING Program as, while they may be considered to be a distributor of public interest journalism as they provide news content to other media outlets, for the purposes of the original PING Program, they would not have been considered to be a regional publisher and as such, would not have met the eligibility criteria set out in the original PING Program Guidelines.

#### Grant guidelines

Although the funding is being provided as an Ad-hoc / one-off grant via direct offer to AAP Newswire, the Department is required to prepare guidelines for all grant opportunities under the Commonwealth Grants Rules and Guidelines 2017. The Department provided the Guidelines at **Attachment A** and associated Risk Register to the Department of Finance. The Department of Finance provided comment on the Risk Register only. The Guidelines are not required to be published.

#### Selection of AAP Newswire

On 3 March 2020, the shareholders of AAP announced that the AAP Newswire would close. The AAP Newswire business was acquired by a new consortium on 4 August 2020. The consortium has provided a limited lifeline to allow the business to restructure and work towards financial sustainability. AAP Newswire's business model is well placed to continue to produce and distribute high quality public interest journalism to the media industry, particularly to regional broadcasters and publishers. The funding reflects the impacts of the COVID-19 pandemic on AAP Newswire and the regional media sector that relies on AAP's newswire services.

AAP Newswire currently services over 100 regional and community news outlets who in turn serve a large majority of regional Australia. The Newswire provides these regional outlets with core public interest content focused on national, state and regional level news. Description of proposed activities recommended by the Department for funding:

1. Production and distribution of public interest journalism through maintenance of regional bureaus

AAP Newswire recently had to close its Darwin, Cairns and Townsville Bureaus. These closures mean that Far North Queensland and Australia's top end have lost a critical source of media coverage for the area. Funding will allow AAP Newswire to reopen these bureaus and cover the salaries and technology required to operate these bureaus.

2. Production and distribution of public interest journalism in regional areas through freelance arrangements

AAP has traditionally had an extensive network of freelance journalists providing coverage of and to regional areas. The model provides numerous benefits to both AAP and the wider media industry including providing regional employment opportunities for local journalists, promoting regional Australian communities to a wider audience and providing coverage of news and events to Australian regional audiences. AAP had to scale back the use of regional freelancers. Funding will be used to support the use of regional journalism freelancers to increase the production of public interest journalism in regional areas. This amount includes part of the producers, editors and planners time required to effectively manage the freelancers' content to ensure it meets the AAP quality.

#### Financial authority

Funding awarded under the PING Program is considered to be a grant for the purposes of the Commonwealth Grants Rules and Guidelines 2017. The Commonwealth Grants Rules and Guidelines 2017 establish the overarching Commonwealth grants policy framework in relation to the administration of grants.

All content produced and distributed by AAP constitutes public interest journalism as it seeks to inform and engage the general public at a local, regional and national level about important issues. AAP's reporting, covering courts, federal and state politics, breaking news, economics, sport and world news, is fact-based reporting by skilled journalists covering matters that are of importance to the people of Australia. AAP Newswire is a key source of public information for many Australians, including, most relevantly, its regional customers and their audiences.

To be found eligible to receive funding under the original PING Program, media outlets had to fall into one of the following categories

- Stream funding pool 1: Regional Television Broadcasters
- Stream funding pool 2: Regional Radio Broadcasters
- Stream funding pool 3: Regional Publishers

AAP Newswire would not have been found eligible to receive funding under the original PING Program as, while they may be considered to be a distributor of public interest journalism as they provide news content to other media outlets, for the purposes of the original PING Program, they would not have been considered to be a regional publisher and as such, would not have met the eligibility criteria set out in the original PING Program Guidelines.

# 3. Who will approve the grant?

The Minister for Communications, Cyber Safety and the Arts will make the final decision to approve a grant.

The Minister's decision is final in all matters, including:

- the approval of the grant;
- · the grant funding amount to be awarded; and
- the terms and conditions of the grant.

The Minister must not approve funding if he reasonably considers the program funding available will not accommodate the funding offer, and/or if the commitment does not represent value for money.

There is no appeal mechanism for decisions to approve or not approve a grant.

# 4. The grant agreement

The funding recipient must enter into a legally binding grant agreement with the Commonwealth represented by the Department of Infrastructure, Transport, Regional Development and Communications (the Department). Consistent with the first stream of the PING Program, the Department will use the *Commonwealth Low-Risk Grant Agreement Template*. Standard terms and conditions for the grant agreement will apply and cannot be changed. A schedule may be used to outline the specific grant requirements. Any additional conditions attached to the grant will be identified in the grant offer or during the grant agreement negotiations.

Consistent with the objective of the PING Program, the grantee will be required to maintain or increase the production and distribution of public interest journalism in regional areas during the grant period (12 months from the date of execution of the grant agreement). The Department will request information from the Grantee, which will include the following:

- details of the activities, budget and timings relating to the expenditure of funds to meet the objective of the PING Program and conditions in the grant agreement;
- six and 12-monthly reports against the stated activities, budget and timings;
- statements to certify that the funding has been acquitted in accordance with the grant agreement (as requested by the Department);
- certified financial or other statements for the full term of the grant (as requested by the Department).
- any supporting information as requested by the Department.

The Department will negotiate an agreement with the grantee. The grant agreement is expected to be finalised by September 2020.

Where a grantee fails to meet the obligations of the grant agreement, the Department may terminate the agreement and recover funding as per the grant agreement. Financial commitments should not be made until a grant agreement has been executed by the Department on behalf of the Commonwealth.

# 5. Announcement of grants

Grants awarded will be listed on the GrantConnect website not later than 21 calendar days after the date of effect as required by Section 5.3 of the Commonwealth Grants Rules and Guidelines 2017.

## Grant acquittal and reporting

The grantee must submit reports consistent with the requirements of the PING Program, with obligations detailed in the executed grant agreement. Reports will include:



#### **Additional Information:**

#### PING Program

On 29 June 2020, you announced that 107 regional broadcasters and publishers would share in \$50 million (GST exclusive) under the first stream of the PING Program. Of the 107 grantees, five are regional television broadcasters; 13 regional radio broadcasters; and 92 regional publishers. AAP would not have been found eligible to receive funding under the original PING Program as, while they are a producer of public interest journalism they would not have been considered to be a regional publisher and as such, would not have met the eligibility criteria set out in the original PING Program Guidelines.

Consistent with the PING Program, AAP will be required to maintain or increase their level of public interest journalism in regional areas. AAP will achieve this in two key ways:

- providing direct support in regional news gathering via funding of local journalists; and
- providing critical indirect support through provision of newswire services to regional publishers which allows them to focus on their own journalist resources on local reporting.

<u>Production and distribution of public interest journalism through maintenance of regional bureaus</u>

AAP recently had to close its Darwin, Cairns and Townsville Bureaus. These closures mean that Far North Queensland and Australia's top end have lost a critical source of media coverage for the area. Funding will allow AAP to reopen these bureaus and cover the salaries and technology required to operate these bureaus.

<u>Production and distribution of public interest journalism in regional areas through freelance arrangements</u>

AAP has traditionally had an extensive network of freelance journalists providing coverage of and to regional areas. The model provides numerous benefits to both AAP and the wider media industry including providing regional employment opportunities for local journalists, promoting regional Australian communities to a wider audience and providing coverage of news and events to Australian regional audiences. This content is distributed into regional areas as part of the supply of the AAP to AAP's regional customer base, which comprises 259 mastheads.

AAP has recently had to scale back the use of regional freelancers. Funding will be used to support production of public interest journalism in regional areas. This amount includes part of the producers, editors and planners time required to effectively manage the freelancers' content to ensure it meets the AAP quality.

Maintenance of production and distribution of public interest journalism to regional areas as core AAP operations

AAP's content constitutes public interest journalism as it seeks to inform and engage the general public at a local, regional and national level about issues of significance to Australia. AAP's reporting, covering courts, federal and state politics, breaking news, economics, sport and world news, is fact-based, unbiased reporting by highly skilled and trained journalists covering matters that are of importance to the people of Australia. AAP is a key source of public information for many Australians, including, regional audiences. Funding will be used to support AAP's core business which will, in turn, enable regional media outlets to focus on producing hyper-local stories relevant to their communities.

# 3. Who will approve the grant?

The Minister for Communications, Cyber Safety and the Arts will make the final decision to approve a grant.

The Minister's decision is final in all matters, including:

- the approval of the grant;
- the grant funding amount to be awarded; and
- the terms and conditions of the grant.

The Minister must not approve funding if he reasonably considers the program funding available will not accommodate the funding offer, and/or if the commitment does not represent value for money.

There is no appeal mechanism for decisions to approve or not approve a grant.

# 4. The grant agreement

The funding recipient must enter into a legally binding grant agreement with the Commonwealth represented by the Department of Infrastructure, Transport, Regional Development and Communications (the Department). Consistent with the first stream of the PING Program, the Department will use the *Commonwealth Low-Risk Grant Agreement Template*. Standard terms and conditions for the grant agreement will apply and cannot be changed. A schedule may be used to outline the specific grant requirements. Any additional conditions attached to the grant will be identified in the grant offer or during the grant agreement negotiations.

Consistent with the objective of the PING Program, the grantee will be required to maintain or increase the production and distribution of public interest journalism in regional areas during the grant period (12 months from the date of execution of the grant agreement). The Department will request information from the Grantee, which will include the following:

- details of the activities, budget and timings relating to the expenditure of funds to meet the objective of the PING Program and conditions in the grant agreement;
- six and 12-monthly reports against the stated activities, budget and timings;
- statements to certify that the funding has been acquitted in accordance with the grant agreement (as requested by the Department);
- certified financial or other statements for the full term of the grant (as requested by the Department).
- any supporting information as requested by the Department.

The Department will negotiate an agreement with the grantee. The grant agreement is expected to be finalised by October 2020.

Where a grantee fails to meet the obligations of the grant agreement, the Department may terminate the agreement and recover funding as per the grant agreement. Financial commitments should not be made until a grant agreement has been executed by the Department on behalf of the Commonwealth.

# 5. Announcement of grants

Grants awarded will be listed on the GrantConnect website not later than 21 calendar days after the date of effect as required by Section 5.3 of the Commonwealth Grants Rules and Guidelines 2017.

# Grant acquittal and reporting

The grantee must submit reports consistent with the requirements of the PING Program, with obligations detailed in the executed grant agreement. Reports will include:

• six and 12-monthly reports against the grantee's stated activities, budget and timings in the grant agreement;


- financial or other statements as requested by the Department that certify that grant money received during the grant period has been spent for the purposes of the objective and in accordance with conditions in the grant agreement; and
- any supporting information requested by the Department.



The Australian Government has allocated a total of \$55 million (GST exclusive) in grants under the Public Interest News Gathering Program (PING) to support the provision of public interest journalism in regional Australia. The objective of the PING Program is to support regional broadcasters and publishers to maintain or increase their production and distribution of public interest journalism in regional Australia during the COVID-19 pandemic phase.

On 29 June 2020, the Minister for Communications, Cyber Safety and the Arts, the Hon Paul Fletcher MP, announced that 107 regional broadcasters and publishers would share in \$50 million (GST exclusive) under the first stream of the PING Program. Grantees are required to enter into agreements with the Department of Infrastructure, Transport, Regional Development and Communications (on behalf of the Commonwealth) and grant information will be published on GrantConnect within 21 days of agreements being executed.

Given the significant economic disruption to the entire media and broadcasting sector arising from the COVID-19 pandemic, an additional \$5 million (GST exclusive) of funding has been made available under the PING Program to provide support to major media businesses who were ineligible to apply for funding under the first stream of the PING Program.

The Australian Associated Press (AAP) Newswire will receive \$5 million (GST exclusive) of the additional funding to support its news services into regional Australia.

AAP content is available to approximately 259 regional news mastheads, all of whom rely on AAP to deliver national, state and regional news to regional readers.
