

Balranald Shire is located in the South West of the state and covers an area of 21,346 square kilometres. The north of the shire has little or no mobile phone coverage.

Council have a number of points why it feels it should be considered in the first funding component of the \$80 million mobile network expansion project, and these are detailed below:

1) Clare Public School is within this no coverage area to the far north of Balranald. (Refer map attached.) Wireless devices such as I-pads are increasingly used in schools for educational purposes and the fast pace of technology will see schools like Clare left behind because they do not have full access to mobile wireless technology.

## Some statistics and facts are:

- 79% 5-14 year olds accessed the internet in 2009 this is up 65% from 2006
- 85% of children who used the internet at home used it for educational purposes
- In 2009, almost a third (31%) of all children, owned a mobile phone
- With portable devices, users can access the internet whenever or wherever they like. Access and use of information technology by children is likely to continue to become easier and more convenient.
- Ipads, Ipods, Laptops, Smartphones are wireless based technologies
- Mobile wireless internet connections are the fastest growing technology
- Almost half of internet connections are mobile wireless
- There are over 11 million mobile handset internet subscribers in Australia



- 2) Willandra Lakes World Heritage Area and Mungo National Park have no mobile phone coverage and have over 50,000 visitors a year. <a href="http://www.visitmungo.com.au/world-heritage">http://www.visitmungo.com.au/world-heritage</a>. This area is located in the North West of the Shire adjoining the Wentworth Shire Council.
- 3) Cristal Mining, a sand mining company, are due to commence production in the near future in Balranald Shire approx. 80 kms north of the Balranald township and plan to use the main road north to Ivanhoe to transport their mining product to the rail head at Ivanhoe. This will significantly increase the transport movements on this road.
- 4) The main road from Ivanhoe to Balranald is part of the proposed "Wool Track" (for further information on the Wool Track please refer to this website <a href="http://www.jlkilby.com.au/projects/the-alternate-inland-highway-feasibility-study">http://www.jlkilby.com.au/projects/the-alternate-inland-highway-feasibility-study</a>).

Council have received funding of 4 million dollars from the NSW State Government to complete the sealing of the Balranald to Ivanhoe Road. The completion of this project will see an increase in transport movements.

5) There are currently radio phone towers located at the properties "Oakdene" and "Min Min" Stations. These towers could be utilised for further technology to provide mobile coverage in these areas. (Refer map attached).

Technology at these sites and a tower at Mungo National Park and in the Clare School area would vastly improve the current lack of coverage.

The Australian Government Regional Telecommunications Independent Review Committee's recommendation 3.2 "a co-investment program, jointly funded by the Commonwealth and interested states or territory governments, to expand the mobile coverage footprint in regional Australia, focusing on priority regions selected with community input. Open-access arrangements for other carriers to tower infrastructure and/or domestic roaming arrangements should be a feature of the program."

 Cristal estimates the NSW Government will receive \$1 million per month in royalties from Cristal mine operations in the Hatfield area alone.


It is beyond the Council and the community to fund mobile phone coverage.
