## **Mobile Coverage Programme – Discussion Paper**

In response to a community meeting held in Birregurra on Tuesday 4<sup>th</sup> February, I am writing to outline some common and also some of my own particular concerns regarding the mobile telephone and internet coverage in the greater Birregurra area (including in particular Barwon Downs) which lies within the Corangamite electorate of Victoria.

### The Current Situation:

The terrain is undulating and in part quite hilly being at the northern edge of the Otways, the Otway State Forest and National Parks. Barwon Downs is the gateway to the Otways, the Great Ocean Road and the coast beyond. It lies just at the rise on the northern edge of the Otways and is flanked by two ridges on the East and West. The road to the south carries traffic from the Princes Highway and Birregurra to Forrest, Skenes Creek and Apollo Bay which makes it an important artery for tourism apart from regular business and residents' travel. Birregurra to the near North and Forrest to the even nearer South have been designated as townships for growth through residential increase and tourism. This will have an impact on Barwon Downs and its infrastructure needs.

Despite a Telstra tower at Mt Gellibrand there are significant 'black spots' with respect to mobile and wireless internet coverage both in the township of Birregurra and all of the surrounding district. Copper land line is in place but from what I have been advised by Telstra in 2009 new dwellings may not be able to be connected to the copper network in the more remote areas due to lack of capacity so the only option is mobile phone communication if at all. During bad weather even the local telephone landlines can be affected. As noted, in some cases people do not have landlines and even if they have some wireless coverage this can be badly affected by adverse weather conditions.

With regard to internet access broadband is not available via wireless signals in many places and ADSL connection is not available or performs poorly at the margins where it is in place.

The areas of concern include the following:

**Public Safety/Emergency Situations** – This includes residents and visitors to the district having access to emergency services as well as members of the local CFA brigades needing to contact each other by mobile phone when a call out occurs. The CFA is usually the first responder to emergencies including motor vehicle accidents, before the police, ambulance and SES. Given the black spots this is a serious problem.

As a matter of note, Barwon Downs was selected by the State Government as one of the first two townships that were the top priority to have 'Community Safer Places' established due the high fire risk in the area and the particular position of the village on the edge of the State Forest and National Park. It is a thoroughfare for tourists as well as normal residential and business traffic.

**Business** – Many of the residents of the district rely on the internet and telephone to conduct their daily business whether it is agriculturally based or not. This will include voice and data transmissions. In my own case, I have a widespread collection of clients including international ones where electronic communication is essential. My mobile connection at Barwon Downs

ranges from zero to two or three bars on the Telstra network. I may be having a conversation and the call drops out. This is and appears to be extremely unprofessional. If the caller has blocked their number I cannot even call them back on the landline!

With respect to internet access, wireless connection is impossible or highly unreliable in many areas including at Barwon Downs. ADSL as noted above is extremely limited in terms of availability so the majority of residents cannot access it. In my case I have ADSL but at peak usage periods by others my connection has dropped out regularly. I have had to upgrade the connection but it can still be a concern and as the copper wire deteriorates it will become worse.

**Social** – Many people rely on wireless communication via mobile or VOIP as well as other internet based social media and emails. There are limited social hubs in rural areas so people may become quite isolated if they cannot communicate electronically. This can have quite an impact on their well-being.

**Education** – In today's age good internet access is critical to being able to attain a good education and this is even more important in rural Australia where students experience additional disadvantages over their city brethren. Poor internet and mobile access further compounds their social and educational disadvantage.

**Regional Development** – As the population growth continues in the major Capital cities there has been a push to have people settle in regional towns and villages. Many people resident in places within a couple of hours of a major or Capital city have moved in over the past ten to twenty years and the push appears for this to continue. Access to satisfactory communications is critical to the success of this. A patchy service is a deterrent and anecdotal evidence has it that people and businesses have left where the service was below expectations. This will not serve Australia well and would be a missed opportunity.

**Future Developments with NBN** – It appears that over time with the roll out of the NBN programme in whatever form, the copper wire connection via the Telstra network will be degraded. At the same time small communities such as Birregurra and Barwon Downs in particular will not be connected. Thus they will be doubly disadvantaged in terms of phone and internet connection.

## My Request:

As the president of the Barwon Downs Community Group and also on a personal basis, I request that the government actively promote the upgrading of the existing telecommunications towers to increase the range and spread of coverage as well as establishment of new towers in the Birrregurra/Barwon Downs region.
