RE: Comments on Spectrum Review Issues Paper

I refer to the Department of Communications discussion paper, Spectrum Review Issues Paper, and the request for comments. On behalf of the SA Government, the Office of the Chief Information Officer, Department of the Premier and Cabinet provides the following comments:

Term of Reference 1:

Simplify the framework to reduce its complexity and impact on spectrum users and administrators, and eliminate unnecessary and excessive regulatory provisions

- To simplify the framework one must first understand which Acts, Instruments and documents currently constitute the framework. The Terms of Reference need to outline the elements of the framework.
- Reduction of regulatory burden is fully supported, providing the overall
 effectiveness of the planning, allocation, licensing, re-issue processes
 and technical regulation and interference management is not weakened
 or the cost transferred to the stakeholders. The Terms of Reference
 must be clear on this matter.
- The Governor-General's powers to declare an emergency are unlikely to be effective in the current form. However, the Terms of Reference should not preclude developing an effective mechanism in support of emergency response.

Improve the flexibility of the framework and its ability to facilitate new and emerging services including advancements that offer greater potential for efficient spectrum use, while continuing to manage interference
