Mobile Coverage Programme Discussion Paper Submission

I am writing today regarding the Mobile Coverage Programme and its importance to the electorate of Flynn. Many parts of the region do not benefit from reliable network coverage, and in many cases, experience no coverage whatsoever.

I have been working with my local communities to establish areas of the highest need within Flynn and have so far identified the following key areas of high priority:

- Boyne Valley (Gladstone region)
- Discovery Coast Town of 1770 down to Baffle Creek/Rules Beach and across to Lowmead and Rosedale (Gladstone region)
- Winfield down to Moore Park Beach and across to Gin Gin's outlying areas including Bucca and South Kolan (Bundaberg region)
- Proston/Durong (South Burnett region)
- Central Highlands including Duaringa, Arcadia Valley and Dawson Developmental Rd (Springsure Tambo Rd)
- Jambin/Callide Valley (Banana region)
- Mount Perry, Monto (North Burnett region)

Details of locations in Banana Shire and Central Highlands regions have been provided by the respective Councils in the attached letters.

The areas listed above do not host the necessary population required to justify 100% private enterprise investment in mobile communications infrastructure. However, despite limited population these areas host significant volumes of seasonal traffic, have been subject to significant natural disasters and are host to substantial resources and agricultural based industry.

In light of over \$100 billion of downstream resources investment and development in the Gladstone Region alone, it has become increasingly apparent that these regions require significantly upgraded communications to cope with the increase in transit from upstream to downstream resources assets.

Added to this the continued development and competitiveness of the regions rich and productive agricultural sector is heavily reliant on technological advancements in communications.

Significant flooding in both 2010/11 and again in 2013 also highlighted the need for better coverage when communities of the Boyne Valley, Lowmead and Baffle creek were physically cut off for significant periods of time and lost all landline communications.

Over the last twelve months, local communities and I have been engaging with Telstra to establish a preliminary understanding of what's required to improve coverage. To date, Telstra have been cooperative and I am confident that we can continue to work together to deliver positive outcomes for the community.

I therefore welcome the introduction of the Mobile Coverage Programme and your consideration of the areas listed above as ideal candidates for cooperative funding to improve communications infrastructure.
