To whom it may concern

Flinders Shire Council would like to submit to the Department of Communications that any strategy to improve mobile coverage in Regional Australia would take into consideration the following:

- The Commonwealth Government's Role in Infrastructure Provision
- The unique issues faced in our region with areas such as Mt Walker that currently blocks any signal heading south.

With the increasing use of the internet and mobile devices for everything from mapping, financial and social interactions, (often during our high tourist season) the internet and mobile signals tends to suffer dramatically. The expansion of access to a widening range of internet based services and the Queensland Digital Economy Strategy having such a predictable shortfall in connectivity, has led to less people and businesses being confidant in relying on internet and other service providers to reliably provide for consumers. This often leads to service provided at an inflated cost or simply not being available in regional areas.

One strategy would be to assess the various joint enterprise and contribution models held with the telecommunication service providers and invest in infrastructure that would otherwise be financially unviable for the private industries. Such arrangements could be standardised and easily requested, as well as negotiated by third parties to ensure value for money and service levels are reached.

Within our region we have areas such as Elvira Station on the Hughenden Winton Road which lacks access to any sort of mobile coverage. The most basic of signal repeater foxed infrastructure would allow people south of MT walker (only 10kms out of town) to access mobile phones and eventually other services the rest of the state has had access to and are already utilising. Optic Fibre runs down along Elvira making it an ideal location for exceptional coverage providing better utilisation.

If any implementation methods are installed, Council ask that the systems and service providers already in place are considered, as well as use local knowledge available in each effected regions by developing a plan that will benefit all mobile users.
