
#### **RE: MOBILE PHONE BLACK SPOT AREAS WITHIN THE TABLELANDS REGIONAL COUNCIL**

I refer to your request for information relating to your Mobile Coverage Programme. Coverage across the Atherton Tablelands is sporadic at best and generally restricted to urban centres.

The Gross Regional Product (GRP) for the Tablelands as of 30 June 2012 was \$1.9bn, of this Agriculture, Forestry and Fishing generated \$710m (representing 37.4% of the total). This sector produces 14% of citrus fruit, 14% of milk and 11.5% of nuts for Queensland. Agriculture is, therefore, not only an important industry for the Tablelands but for Queensland as a whole. Agriculture is also the largest employer in the region with 3,788 jobs in 2011/2012.

The Tablelands has a varied climate, rich agricultural soils and plentiful irrigation water, which makes it a primary target for infrastructure investment to help meet the Coalition's target of developing a food bowl, including premium produce, which could help to double Australia's agricultural output.

Reliable communications technology is required now to ensure that the industry can exploit the many new opportunities offered across the full value chain from crop cultivation through harvesting, product handling and packaging, quality management and marketing. Unfortunately, Infrastructure on the Tablelands is sporadic at best and, particularly away from town centers, is simply not available. Consequently growth rates in the agricultural industry on the Tablelands are now falling significantly behind those across Queensland as a whole with a consequential impact on employment.



Council recently conducted a survey on communications coverage across the region; key results from this show that:

- 22% of respondents have no mobile telephone coverage at all;
- of those that do have access 46% have 2 bars of reception or lower; and
- 23.2% of respondents, who have access to a mobile network, experience 50% or more calls dropping out each day.

Please find listed below some of the areas that have been identified through consultation with constituents, personal knowledge as well as information gained through Council our community survey.

#### **Mobile Phone Blackspot Areas**

- Southern end of Marnane Road, Tolga down to the 'Igloo' area at Rocky Creek.
- Innot Hot Springs
- Wondecla
- Watsonville
- Irvinebank
- Gillies Range from the top of the Tablelands into Malanda
- Topaz Some areas of Butchers Creek and many spots between Malanda and Atherton, Malanda and Millaa Millaa
- Tarzali Pockets of no or limited coverage in the town of Tarzali eg coverage deteriorates rapidly down Sheehan Road Tarzali to no coverage at the end (the valley end)
- Ravenshoe 12081 Kennedy Hwy, aka Chilverton / Evelyn /Ravenshoe. South west of Ravenshoe, around Marshall Park on Wooroora Road.

#### **Other Telecommunications Issue**

The town of Ravenshoe identified the need for improved telecommunications and for Telstra to install a back up generator at the Telstra tower to improve mobile phone service, Internet, TV and radio services and UHF reception for handheld radios by emergency services.

A check on the three major telecommunications industry's websites, Telstra, Optus and Vodafone indicates there are numerous blackspot areas throughout the region, however, the results are dependent on the customer's type of handset - e.g. 3G, 4G, etc.
