

## **SUBMISSION FOR ENQUIRY COMMISSION ON SBS**

My submission on SBS is based on experience and continuous following of SBS Hindi and Punjabi (Multicultural channels).

I will focus on The biased , partial and at times redundant news that racially vilify and target Indians and in particular Hindus.

Below are my few points followed detailed explanations and proofs where available:-

1. SBS is exploiting legal loopholes to further propaganda and hatred against Indians and Hindus in particular
2. SBS is publishing fake news that have deep impacts on reader's conscience publicly but when caught only apologies privately and denies public apology
3. SBS is trying to meddle with elections of other countries by spreading biased news and again denies to apologise publicly.
4. It is racially profiling Indians to portray as mischievous criminals even when the news is not related to Australia
5. Some journalists are just repeating and recreating same stories from India which are easily accessible to readers through other digital mediums and hence wasting tax payers money
6. SBS journalists enjoys financial protection and irrespective of the listenership of their shows, hire too many journalists that other private players cannot afford

### **1. SBS is exploiting legal loopholes to further propaganda and hatred against Indians and Hindus in particular**

As per the SBS Act, ACMA can investigate any matters of code complaints that are broadcasted on their radio or tv programme if the complainant is not happy with the outcome of SBS investigation.

However whatever is published on their social media pages , ACMA cannot investigate it.

### **2. SBS is publishing fake news that have deep impacts on reader's conscience publicly but when caught only apologies privately and denies public apology**

SBS ran a completely fake story that India was searching caste of a sportswoman but when caught it only apologies in private. Such stories have big impact in the community and incite hatred and hence they should publicly apologise for it.
